The auditory process of speech is now being examined closely, along with the possibility of extension to clinical practice.

LTI greatly values its business in Australia, and marketing and engineering personnel visit the country regularly. LTI also participates regularly in trade shows and exhibitions in Europe and the United States to help stimulate export opportunities.
