NOTICE OF STATUTORY PUBLIC MEETING

GTA West Transportation Corridor Protection/Halton Hills Employment Lands Phasing

The Council of the Town of Halton Hills will host a Public Meeting regarding a proposed Official Plan Amendment to implement policies to protect for the future location of transportation corridors in Halton Hills, identified in the Halton Peel Boundary Area Transportation Study (HPBATS), as well as the GTA (Greater Toronto Area) West Transportation Corridor Environmental Assessment (EA).

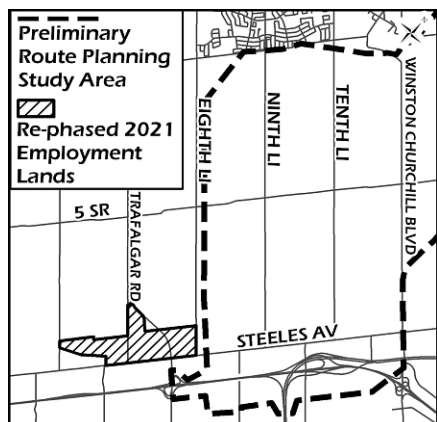

PLEASE NOTE

1. If you wish to be notified of the adoption of the proposed official plan amendment, and the decision of the Town of Halton Hills on the proposed modifications to Official Plan Amendment No. 10, you must make a written request to the Town of Halton Hills – Planning, Development & Sustainability Department at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.
2. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision of the Region of Halton to the Ontario Municipal Board.
3. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.
4. Any written comment/objection submitted to the Town of Halton Hills regarding the amendments which are being processed under the *Planning Act*, may be made public as part of the application process.



The portion of the GTA West Preliminary Route Planning Study Area within the Town of Halton Hills includes lands bounded by (Refer to Key Map):

- i) North – 10 Side Road and the Hamlet of Norval
- ii) East – Winston Churchill Blvd.
- iii) South – Highway 401
- iv) West – rear lot line of lots fronting on Eighth Line

Purpose and Effect of the Proposed Amendment:

The proposed amendment will implement corridor protection on the lands within the Preliminary Route Planning Study Area to prevent development that would preclude the future location of transportation corridor(s), pending the completion of the GTA West EA process, and any EA for an East-West connection identified in HPBATS.

The Town also proposes to implement modifications to Official Plan Amendment No. 10 in order to re-locate/re-phase the Town's supply of employment lands to the 2021 planning horizon in the area west of Eighth Line, north of Steeles Avenue, outside of the Preliminary Route Planning Study Area (Refer to Key Map). The Town of Halton Hills would then initiate a land use planning exercise (i.e. secondary plan) for those lands and potential additional lands.

Additional Information:

Following the statutory public meeting, Town staff will prepare a report to Council which will respond to oral and written comments received, and provide a final recommendation on the proposed Official Plan Amendment and proposed modifications to Official Plan Amendment No. 10.

Regional Councillor Jane Fogal has received a Bicycling Leadership Award from The Share the Road Cycling Coalition.

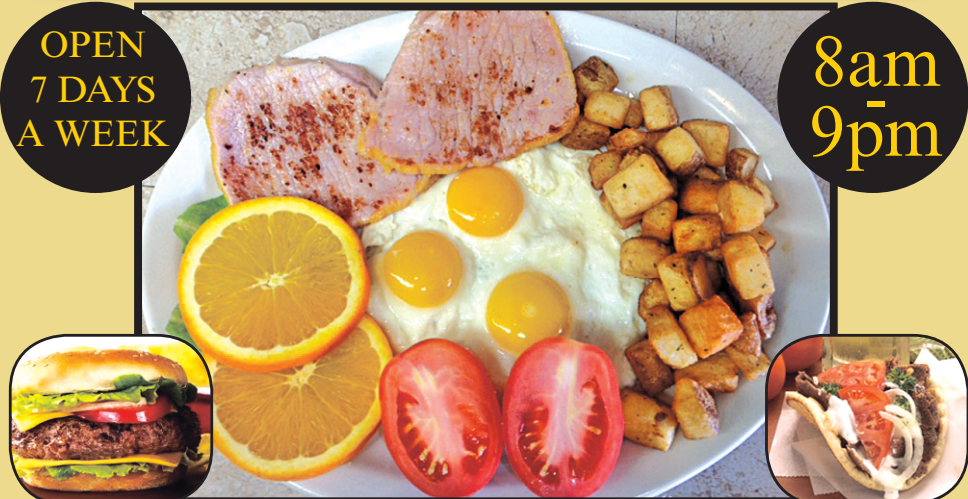
