WATERLOO — To mark the 60th anniversary of the Universal Declaration of Human Rights, the Academic Council on the United Nations System (ACUNS) is convening a panel of experts on Dec. 10 to discuss the current state of human rights internationally.

This public event — titled, *The Universal Declaration of Human Rights at 60: How far have we come? How far to go?* — will be held in the Paul Martin Centre at Wilfrid Laurier University, starting at 7 p.m.

On Dec. 10, 1948, the General Assembly of the United Nations adopted the Universal Declaration of Human Rights. The document has inspired people around the world with its recognition of “the inherent dignity and of the equal and inalienable rights of all members of the human family.” Yet its promise is unfulfilled as vulnerable populations around the world still face humanitarian crises in their daily lives. Why is this so?

- **Dr. Ramesh Thakur**, Director of the Balsillie School of International Affairs and former Vice-Rector of the United Nations University.

“We’ve made so much progress internationally on respect for human rights, and the Universal Declaration is a huge part of that. But, at the same time, we’re reading about displaced persons in the Congo and other humanitarian crises every day. Our panel will help us understand why a gap between international policy and personal experience still persists,” said Laurier professor Dr. Patricia Goff, executive director of ACUNS and a Senior Fellow at the Centre for International Governance Innovation.
