**SPECIAL ATTENTION** — None but registered deed-holders and registered agreement for sale holders are placed on list. Where agreement is registered deed holder cannot vote on same property. Agreements or deeds must be registered at the Land Registry Office, Vancouver, B.C., on or before 30th November, 1929.

**The List is closed on  
Saturday, November 30th.**

A Corporation the name of which is on the voters' list shall vote only by its duly authorized agent, whose authority shall be filed with the Clerk of the municipality on or before the thirtieth day of November, and who shall be a resident of the Province and a British subject of the full age of twenty-one years; and such agent shall be entitled to vote for the corporation from year to year until his appointment as agent is cancelled and the Clerk has notice of the cancellation.

## HON. H. H. STEVENS GIVES SPLENDID ADDRESS TO UNITED CHURCH MEN'S CLUB

The monthly meeting and supper of the Club was held on Tuesday evening with a large attendance. The Women's Association catered for the supper. Mr. J. Haydn Young led in the community singing.

The Hon. H. H. Stevens gave a brilliant address on "A Layman's Creed."

Some of the address dealt with highly debatable and controversial problems in Science and Biblical thought but the main appeal of the address was in regard to a man's need of giving a chance to his religious instinct.

Men are deeply interested in religious matters although reticent in speaking of them.

The religious instinct is universal, natural, persistent, sure, and safe to follow, yet it may be driven out of the life.

Mr. Stevens protested against a materialistic interpretation of the universe, and against a materialistic evolutionism.

In support of that contention of the speaker it is interesting to note that the hypothesis of Evolution which has won its way and is accepted by practically the whole scientific world, is today expounded by scientists who reject a doctrine of scientific materialism.

A spiritualistic interpretation of evolution was never so pronounced as today as in the hands of J. Arthur Thompson; J. Y. Simpson, Whitehead, Eddington, Osborne and others who all speak with anti-dogmatic and guarded care, whilst absolutely convinced of the general truth of Evolution.

In listening to the address one was glad to feel that the protest against materialism was also the protest of the best of modern thinkers.

Leaving aside all matters with which some of his hearers might disagree, Mr. Stevens gave a series of articles in a layman's creed the following:

1. Humanity's greatest need is God, and its creed begins with the simple statement "God Is."

2. He is interested in man; He cares for man.

3. Man is of a three-fold nature—physical, mental and spiritual. The last being the most important part of him.

4. God has revealed Himself through human agencies and through Jesus of Nazareth.

The unfolding of Himself would seem to logically follow from his existence.

5. A layman can accept the general inherent soundness of Scripture apart from all questions of technical perfection.

6. Man knows when he is wrong; is conscious of sin. He knows good from evil.

There is need today of recognizing the importance of conscience and the sense of personal responsibility for human evil.

On account of the Xmas season there will be no meeting of the Club in December. The next gathering will be in January.

## DAN KING BUYS NORTH VANCOUVER SAWMILLS PAYING \$60,000 CASH

Dan King of the Vancouver Pile Driving & Contracting Co., has purchased for \$60,000 cash, the North Vancouver Sawmills.

The site, which is located at the corner of Esplanade and St. Andrews avenue, comprises lots 14, 15 and 16, block 175 and lot 1, block 173, D.L. 274. This is the largest deal in waterfront property negotiated here for some time.

Early in October the manufacturing portion of the mill plant was destroyed by fire with a loss of \$85,000. The new owner has not yet stated whether the plant will be rebuilt.
