## ORDINANCE NO. 1541

## AN ORDINANCE

adopting the recommendations of the Electrical Commission of the Village of Wilmette, and establishing safe and prac-tical standards and specifications for the installation, alteration, and use of electrical equipment designed to meet the necessities and conditions that prevail in the Village of Wilmette, and establishing reasonable rules and regulations governing the issuance of permits by the Electrical Inspection Department, and establishing reasonable fees to be paid for the inspection by such Electrical In-

for the inspection by such Electrical Inspection Department, of all electrical equipment installed or altered within the Village of Wilmette, and providing a penaity for violation thereof.

WHEREAS, the Electrical Commission of the Village of Wilmette has recommended (1) as the safe and practical standards and specifications for the installation alteration and use of electrical stallation, alteration and use of electrical equipment designed to meet the neces-sities and conditions that prevail in this village (2) as the reasonable rules and regulations governing the issuance of permits by the Electrical Inspection Department, and (3) as the reasonable fees partment, and (3) as the reasonable fees to be paid for the inspection by such Inspection Department of all electrical equipment installed or altered within this Village, the standards and specifications, the rules and regulations and the fees, respectively, hereinafter provided: There-

BE IT ORDAINED BY THE PRESI-DENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILMETTE: SECTION 1: Pursuant to the recom-mendation of the Electrical Commission of the Village of Wilmette, there are hereby adopted as the safe and practical standards for the installation, alteration, and use of electrical equipment in the Village of Wilmette:

FIRST: The rules and regulations of the National Board of Fire Underwriters as contained in the code known as the National Electrical Code, and as approved by the American Engineering Standards Committee, and as last published and.

SECOND: The rules and regulations regarding the installation, alteration, and use of electrical equipment as last and use of electrical equipment as last adopted by the electricity supply company now supplying the Village of Wilmette, and as last published and filed with the Illinois Commerce Commission, a copy of said code and said last mentioned rules and regulations being now on file in the office of the Chief Electrical Inspector, and the provisions of said code and of said rules and regulations being hereby made a part of this ordinance.

SECTION 2: Pursuant to the recommendation of the Electrical Commission

there are hereby adopted as the reasonab. rules and regulations of the Village of Wilmette, governing the issuance of permits by the Electrical Inspection Department, the following, to-wit:

(a) Permits for the installation, alter-

ation, and use of electrical equipation, and use of electrical equipment shall first be issued only on receipt of an application therefore made out on a printed form, to be furnished by the Chief Electrical Inspector, or his duly authorized deputy, and submitted to the Electrical Inspection Deposits of the Electrical Inspection De partment, and upon the payment of the fee in advance, as herein-

after provided.

The application for each such permit shall contain the name of the owner, or user of the electrical equipment to be installed, altered or used and the leasting.

trical equipment to be installed, altered, or used, and the location by street and number, and a detailed description of the same.

SECTION 3: Pursuant to the recommendation of the Electrical Commission of the Village of Wilmette there are hereby adopted as the reasonable fees to be paid for the inspection by such Electrical Inspection Department of all electrical equipment installed or altered within the Village of Wilmette, the following, to-wit:

(a) Permits for all electrical work,

(b) Wiring for incandescent lighting, and motors of less than ½ H. P. (Plus .05 per outlet, switch and base plug to be counted as out-

Electric Signs \$3.00 Each re-inspection of any over-

head, underground or interior wires, or equipment shall be charged for according to the time required for such re-in-spection by the Electrical In-spection Department, at the rate of \$2.00 per hour.

(h) Whenever extra inspections are made on account of inaccurate or incorrect information, failure to make necessary reports of faulty construction a charge of \$2.00 per hour shall be made by the Electrical Inspection Department for time consumed in making extra inspection.

No inspection shall be made for

(i) No inspection shall be made for less than \$2.00
SECTION 4: All fees herein provided for shall be paid to the Village Collector.
SECTION 5: Any person, firm, or corporation that shall wilfully fail or refuse to comply with the provisions of this ordinance shall be deemed guilty of an offense punishable upon conviction by a fine of not less than Five (\$5.00) Dollars nor more than Fifty (\$50.00) Dollars for each such offense, and in case of a continuing failure or refusal each day's continuance thereof shall be a separate and distinct offense.

SECTION 6: The term "electrical equipment" as used in this ordinance means conductors and equipment installed for the utilization of electricity supplied for light, heat, or power, but does not include radio apparatus or equipment for wireless reception of sounds and signals, and does not include apparatus, conductors, and other equipment installed for or by public utilities, including common carriers, which are under the jurisdiction of the Illinois Commerce Commission, for use in their operation as public utilities.

SECTION 7: All ordinances, or parts thereof, in conflict with any of the provisions of this ordinance, are hereby re-
