CAMP "BUG" BITES **NORTH SHORE SCOUTS**

Extra Session for North Shore Council Troops Planned at Ma-Ka-Ja-Wan Retreat

Karl D. King, 914 Greenwood avenue, Wilmette, president of the North Shore Area council of the Boy Scouts of America, reports that the enrollment for Camp Ma-Ka-Ja-Wan the new council training camp at Elcho, Wis., has exceeded all expectations. As a result Mr. King announces the camp will be held oen for an additional period of two weeks to accommodate more Scouts who desire to enroll.

The camp has a capacity of one hundred Scouts. It was originally planned to have three two-week sessions on the following dates, July 5-July 20, July 19-August 3, and August 2-August 17. Paid reservations are in the council headquarters for one hundred Scouts, each, for the first and second sessions and only a very few places remain for the third session. Hence the decision of the Executive board of the council to open a fourth session to run from August 16-August 31 to permit other Scouts to attend, particularly those who are in summer school and cannot take advantage of the earlier sessions. The fourth session, however, will be contingent upon at least sixty Scouts enrolling by not later than the last of July, it is explained.

Mr. King says the camp is in complete running order and ready to receive the first group of one hundred who will leave for camp Friday, of this week.

The North Shore Area council is comprised of the communities of Wilmette Kenilworth, Winnetka, Hub-bard Voods, Glencoe, Ravinia, Highland Park, Highwood, Lake Forest, Glenview, Northbrook, Deerfield, Ban-nockburn, Libertyville, Mundelein, and Diamond Lake. Last year 150 Scouts attended the Chicago camp, but since the council has started its own camp. the registrations to date indicate an increase of over 100 percent for 1929. Further increases are expected for succeeding years as the Scouts bring back the news to their comrades about this wonderful north woods camp.

Urge Physical Exams for All Kindergarten Pupils

The parents of the children in kindergarten this coming fall are asked by the Wilmette Parent-Teacher associations to have their children examined by the family physician so as to correct possible physical defects during the summer. This will be to the child's advantage, it is pointed out. Each child will receive examination when entering kindergarten in the fall.

PLAN TENNIS TOURNEY

Annual Wilmette Championship Event to Be Staged at Village Green From July 15 to August 1

Plans for the fourth annual singles tennis tournament conducted by the Wilmette Playground and Recreation board have been announced by the recreation staff and the date set for July 15 to August 1.

Contestants wil be divided into two classes-seniors and juniors. The juniors will include players under 15 years of age and separate tournaments will be held for boys and girls. The same plan will be in effect in the senior division and tournaments will be conducted separately for men and womers above 15 years of age.

The rules, as announced by Dudley C. Stone, recreation assistant in charge of the tournament, stipulate that all games must be played on the Village Green courts. Entrants will be received up to and including July 13 at the Recreation office, Tenth and Central streets, and may be made by telephone, Wilmette 468, or with Mr. Sione personally.

Tournament players must be residents of Wilmette and must play the game as scheduled at the recreation office. Pairings will be made after 2 o'clock Saturday, July 13, and the first games will be scheduled for July 15.

A gold medal will be awarded to the winner in each division and a silver medal will be given to the runner up in each division.
