# **BEGIN VILLAGE BALLOT FIGHT**

#### Politics Takes First Place in Discussions; Two Major Tickets in Field

With the final date for filing election petitions gone, Wilmette political alignments for the forthcoming Village election Tuesday, April 21, retained the status prevailing last week.

Two major parties will fight it out for the favor of the voters, and there will be two independent tickets.

First to file for a place on the ballot was Herman T. Reiling, lone candidate of the Taxpayers' party, who is seeking the office of Village Treasurer. Next in order of filing was the Public Welfare party, with candidates for all offices except that of Village Treasurer; next the Independent party, whose candidates, in accordance with tradition, are two unopposed candidates for directors of the Free Public library; and lastly the Civic party, which has placed a complete slate in the field for Village offices.

Mr. Reiling and the Public Welfare party originally presented certificates of nomination, followed later by petitions. The Independent library ticket and the Civic party filed by petition only.

#### See Interesting Fight

Indication of an intensely interestthat the Public Welfare ticket, headed by Carbon P. Dubbs, candidate for Village president, this week opened two headquarters, one at 1157 Wilmette avenue, and a second at 805 Ridge road.

No headquarters have been established as yet by the Civic party, which has Frederick J. Newey, as its candidate for Village president, but reports were rife that such activity would be forthcoming within a few

Candidates of all parties are soon to have an opportunity to discuss issues in public assembly. The Wilmette Civic league this week sent written invitations to all nominees to speak at a mass meeting to be held in the Stolp school auditorium Friday evening, March 27.

#### Board of Education Selects Eastern Educator for Superintendent Post

The Board of Education of New Trier Township High schoool has announced the selection of Matthew Page Gaffney, M.A., of Great Neck, Long Island, as superintendent of New Trier High school to succeed the late Frederick Edson Clerk. Mr. Gaffney will assume his new duties in September, 1931.

Mr. Gaffney graduated with the degree of Bachelor of Science from Colgate university in 1912. He received his M.A. degree from Columbia university in 1919. He has acted as principal of the Williamson, (N. Y.), High school, the headmaster of the Roger Aschen school at Harts-dale, N. Y., principal of the Central High school at Aberdeen, S. D., city superintendent of schools at Aberdeen, S. D., and principal of the Great Neck High school, Great Neck, N.Y.

#### **Board Scours Country**

Mr. Gaffney's selection comes as the climax of a long and careful investigation by the Board of Edu-cation. Early last fall Edward J. Phelps of Kenilworth made a two months' tour of the East and Middle-Western states, and submitted a very complete report of available candidates. Subsequently the Board of Education eliminated from this list all but four candidates. Mrs. Janet S. Gordon of Winnetka, the president of the Board, visited each of the four schools in which these candidates were serving, and observed the work and abilities of each. The final selection of Mr. Gaffney, therefore, stamps him as the outstanding candidate for the position of superintendent at New Trier.

Among the prominent educators recommending Mr. Gaffney for this position were Dean Thomas H. Briggs of Columbia university, Prof. Elbert K. Fretwell of Teachers college, Columbia, Associate Professor Harold Rugg of Teachers college, Columbia, and Prof. O. S. Wood of Denver university, Denver, Colo. Recommendations were also received from I. N. Douglas, president of the Board of Education of Aberdeen, S D., and from Jacob Brasser, former president of the Board of Education of Williamson, New York.

#### Leader in Boys' Work

Mr. Gaffney has traveled extensively and spent a portion of last year in Europe touring Brittany and Switzerland. He has also been active in boys' camps and has for seven years been associated with a wellknown camp in Bridgetown, Maine. His interests lie also in the field of theater and music. He has taken active part in amateur theatricals, both as director and actor, and has written and produced several short skits.

Mr. Gaffney is married and has two sons, aged 9 and 7 years. He expects to take up his residence in Winnetka, and may possibly spent part of the coming summer in or about the north shore.
