REQUEST BIDS ON N. T. BONDS

High School Board of Education Offers \$420,000 Issue to Investors

The New Trier High school board of education, Jesse R. Gathercoal, president, this week published a notice that sealed bids for the purchase of high school building bonds of the district in the amount of \$420,000, will be received at the high school until 8 o'clock (daylight saving time), July 9.

Bids may be entered for the purchase of the whole or any part of the \$420,-000 bond issue, it is stated.

The bonds are issued for the purpose of erecting a new building on the high school grounds and making an addition to the present structure.

It is pointed out that the bonds to be sold at this time represent \$420,000 of the \$875,000 bond issue approved by the voters in the school district several months ago.

The bonded indebtedness of the high school as of July 1, 1931 totals only \$390,000, which applies to the new gymnasium erected more than a year ago. The bonding power of the district exceeds \$2,000,000, it is explained.

The high school officials are hopeful that New Trier residents will be in the forefront in taking advantage of the splendid investment represented in the \$420,000 bond issue now to be sold.

LOW BIDS WIN SCHOOL JOBS

6-Room Addition to Howard Will Be Completed for \$35,000

Contracts for the proposed new sixroom classroom addition at the Howard school were let at a meeting of the Wilmette board of education last week. In every case the contracts were awarded to the low bidders, Supt. J. R. Harper of the Wilmette Public schools states.

McKeown Brothers of Chicago were awarded the general contract. Their bid was \$27,792. The total cost of erecting the addition, including the general contract, plumbing, heating and ventilating, electric wiring and architect's fees, will be only \$35,000. This is \$9,000 less than the amount authorized by Wilmette voters at a special election Monday, June 15.

Let Plumbing Contract George A. Kearney of Evanston has the contract for the plumbing work in the proposed new addition. The heating and ventilating contract went to the Northwestern Heating and Plumbing company of Evanston. The Chester Johnson Electric company of Chicago will do the electric wiring.

Because of the rapidly increasing school population in the western section of the village, the board of education found it necessary to provide some means of taking care of the larger enrollment at the Howard building. It was decided to present to the voters a proposal for the issuance of bonds to the amount of \$44,000 to build a classroom addition.

Make Economy Move

The board took this step, feeling that now is the time to build, when the price of materials is low. Wilmette citizens responded by authorizing the bond issue by a vote of 100 to 59. The board immediately went ahead with the awarding of contracts, so that the new addition will be ready for use when school opens in September.

The six new classrooms will be built above the present one-story wing west of the main unit of the Howard school.
