

READY TO OPEN WINNETKA MART

Annual Community House Exposition to Attract House- holders of North Shore

Heralding three days of varied entertainment, three days of demonstration and instruction in the newest in merchandise, the doors of Community House in Winnetka will open officially at 1 o'clock Tuesday afternoon of next week for the second annual Winnetka Community House exposition. The remaining two days, Wednesday, March 29, and Thursday, March 30, the hours of the exposition will be from 11 a. m. to 11 p. m.

"Looking Forward—Spirit of 1933" is the slogan for the event which promises to be one of the most carefully planned, artistic, and elaborately entertaining trade carnivals sponsored on the north shore. Admission is free, but no one will be admitted without a ticket. Tickets may be obtained at the offices of the merchants who have booths at the exhibit.

Cooking School Feature

A cooking school, a style show and a meat-carving school are among the principal attractions. Sessions of the cooking school will be held at 2 p. m. and 8 p. m. on Tuesday and Thursday. The style show will be presented twice, at 3 p. m. and at 8 p. m. Wednesday. There will be carving demonstrations twice daily, while general carving information will be given to visitors throughout the exposition.

Winnetka women, under the direction of Mrs. William B. Moulton, will demonstrate tables set correctly for breakfast, luncheon, supper and afternoon tea.

Exhibit Camp

An exhibition of "Duke" Childs' camp, O-Wa-Kon-Ze, a model electric train, and jigsaw puzzles will attract the boys and girls.

Automobiles, oil burner and electrical household equipment, band instruments demonstrated by a musician, and oil products are but a few of the assorted types of booths which will display merchandise.

George Getgood, director of Community House, is managing the exposition, assisted by an advisory committee composed of Robert F. Doepel, Harvey N. Bowen and E. A. Anderson.

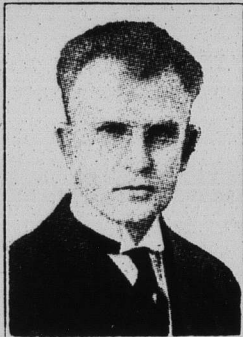
VACATION BEGINS APRIL 7

Want Traffic Lights at Skokie Blvd. Crossings

Village Manager C. M. Osborn has been instructed by the Village board to request the state highway department to install traffic signal lights at the intersections of Skokie boulevard with two important east-and-west cross streets, Lake avenue and Glenview road, as soon as the remaining links in the boulevard are completed across Wilmette. This action was taken by the Village board Tuesday night on recommendation of Trustee Arthur Lee, chairman of the streets and alleys committee. Work on Skokie boulevard is expected to be completed in the near future, and when flow of traffic is expected over the road.

Appoint Judges, Clerks for Village Election

Judges and clerks for the annual Village election on April 18 were appointed at the regular meeting of the Village board Tuesday night. An effort was made to select for the election jobs, insofar as possible, persons who are unemployed, it was explained. Lists of the unemployed were obtained from each precinct.

Name Kenilworth Candidates for Park Board Posts

Petitions have been filed on behalf of John F. White, 270 Oxford road, and Herbert J. Prussing, 549 Earleton road, for membership on the Kenilworth Park board. Two members are to be elected to the board on Tuesday, April 4, to fill two vacancies.

Mr. White has been nominated for a full six-year term to replace Joseph Joyce, whose term expires this spring. Mr. Prussing has been nominated to fill the vacancy caused by the resignation and subsequent death of Edward F. Hamm. Mr. Hamm's term had two years to run.

Filing time for candidates for the Kenilworth Park board posts has expired, and inasmuch as petitions were filed only for Mr. White and Mr. Prussing their names will be the only ones appearing on the ballot, it is explained.

R. W. Starrett is president of the Park board. Other holdover members of the board are Herbert B. Taylor and Mrs. Bentley G. McCloud.
