

UNRETURNED SALES TAX . . .

what WILMETTE INDEPENDENT MERCHANTS *will do with it . . .*

Questions have been raised from time to time about what will become of the unreturned Sales Tax, recently declared unconstitutional by the Illinois Supreme Court. Acting under the leadership of the Illinois Chamber of Commerce, the Wilmette Chamber of Commerce circulated the below printed pledge* among its members. Signatures of the co-operating merchants are also listed. This explains what your local independent merchant plans to do with the unreturned Sales Tax in his possession.

"We the undersigned merchants of the Village of Wilmette, in order that the proceeds received from the collection of the recent Illinois State Sales Tax be used for the proper purpose for which it was collected, do hereby agree to turn over to the Local Board of Wilmette Charities on or before July first all such proceeds remaining after deducting refunds and expenses incurred. The afore-mentioned proceeds to be dispensed to the unemployed and needy of the Village of Wilmette IN PAYMENT OF SERVICES RENDERED to said Village for cleaning, beautification or other civic needs."
