

Leslie L. Perry, Noted Engineer, Taken by Death

Leslie Lawrence Perry, 1127 Greenwood avenue, Wilmette, died suddenly on February 1 at Cuttingsville, Vt.

Mr. Perry was born at Lawrence, Mass. in 1874. After graduating from Tufts college, class of 1896, he began his career in electrical engineering, to which profession he devoted the best years of his life. His early work in this field was with the extensive power generation and distribution interests of the late Dr. F. S. Pearson. This work took him on extended trips to Canada, Mexico, Brazil, Argentina and various countries of Europe.

From 1897 to 1900 and again from 1909 to 1911 Mr. Perry was with the General Electric company at Schenectady, N. Y. During the past 24 years he has been prominently associated with the large engineering firm of Sargent and Lundy, Chicago.

Mr. Perry was a fellow of the American Institute of Electrical Engineers and a member of the Western Society of Engineers. To these organizations he made numerous contributions of papers and reports based on his wide knowledge of the first hand experiences in his chosen field. These organizations in turn honored him with appointments to various important committees.

Mr. Perry was a member of the First Congregational church of Wilmette and had served on its board of deacons.

Surviving him are his widow, Katherine Russell Perry; a daughter, Mrs. Dorothy Perry Johnson of Kiel, Wis.; two sons, Russell L. Perry, of Davis, Calif., and Theodore H. Perry of Niagara Falls, N. Y.; two brothers and two sisters.

The funeral services were held at Rutland, Vt. on Tuesday, and burial was at Chester, Vt.

FACTS ABOUT LOCAL ELECTIONS

Information Regarding Elections, Filing Dates
and Related Matter of Interest to Voters

For the information of readers interested in local government and the selection of capable officials for various elective offices, WILMETTE LIFE herewith presents, in condensed form, facts concerning the various local elections in which citizens participate. The date of holding elections and other information is the subject of frequent inquiries. In this form it may be filed for reference.

Wilmette Village Election

Held on the third Tuesday in April, the 1935 date being April 16. The polls are open from 6 a. m. to 5 p. m. Certificates of nomination, petitions and other nomination papers must be filed with the Village Clerk not less than 35 days nor more than 60 days in advance of the election date. For 1935 the first filing date will be February 15, and the final date March 12. Withdrawal of candidates must be made within 5 days from the final filing date.

At the 1935 election the following Village officials are to be elected: President of the Village board; six Trustees: one Village Clerk; one Village Treasurer.

A recently enacted state law provides that the terms of elective Village officials shall be for two years, and shall expire concurrently. The Village treasurer may not succeed himself. In conformity with this statute, there will be no Village election in 1936.

Library Board Election

Occurs on the same date as the Village election, being April 16 for the 1935 election. The same rules and dates for filing petitions and other nomination papers apply as for the Village. Two members of the Library board are to be elected this year. The names of candidates appear on the official Village ballot.

Wilmette Park Board Election

Held on the first Tuesday in April, which in 1935 will be April 2. The polls will be open from 6 a. m. to 5 p. m. Petitions and other nominating papers must be filed with the secretary of the Park board not less than 40 days in advance of the election date. Three members of the Park board are to be elected in 1935.

The Park board election is usually held in conjunction with the New Trier township election, utilizing the same polling places. As there will be no township election in 1935, the Park board will probably designate two, or possibly three, polling places, where all qualified electors of the Park district may vote.

Wilmette Board of Education Election

Occurs on the second Saturday in April, which in 1935 will be April 13. Polling places and hours will be contained in the legal notice of election. Nomination papers and petitions must be filed with the secretary of the Board of Education not less than 21 days in advance of the date of election. A president and two members of the board are to be elected in 1935.

New Trier Township Election

Held on the first Tuesday in April. Polls open from 6 a. m. to 5 p. m. Petitions and other nomination papers must be filed with the Town Clerk not less than 40 days in advance of the date of election. There will be no Township election in 1935.

New Trier Township Board of Education Election

Occurs on the second Saturday in April. Hours and polling places will be stated in official election notice. Petitions and other nomination papers must be filed with the secretary of the board not less than 10 days in advance of the election. One member of the board is to be elected in 1935.
