WILL DEDICATE **NEW P. O. HERE** THIS SATURDAY

Announce Open House 1:30 to 9; Formal Dedication Set for 3 O'clock

With the raising of the stars and stripes above the structure, the new Wilmette post office was thrown open to the public Monday morning, November 25. While there are still some finishing touches to be put on, the building is practically complete, and the furniture and other equipment in place. Postmaster Herbert L. O'Connell and his force of assistants worked arduously Saturday night and Sunday transferring records and supplies to the new location, so that everything was in readiness to open the doors Monday morning.

Simple Colonial Design

Wilmette citizens have every reason to be proud of this new government building. Its simple Colonial architecture blends beautifully with its attractive surroundings, and when the landscaping is completed will be one of the beauty spots of the village. The interior, too, has been splendidly designed, with its spacious lobby, large work room and handsomely appointed postmaster's office.

In order that all villagers may have an opportunity to view the new building and its interior, Postmaster O'Connell has arranged to keep open house from 1:30 until 9 o'clock, Saturday, November 30. A cordial invitation is extended to all villagers to take advantage of this opportunity. Mr. O'Connell and several assistants will be present to conduct groups through the building and explain the system of handling the mails.

RENEW PLEA FOR **CONTRIBUTIONS** TO LOCAL CHEST

Pass Half-way Mark in Annual Welfare Fund Drive; President Kinne Sounds Appeal

The total reported in the Wilmette Community Chest campaign up to last Friday night was \$13,575. There has been no further report meeting since that date, but workers have been coming to headquarters, bringing their reports, so that this amount has been increased by more than a thousand dollars at the time that this article is being written.

The workers are showing great enthusiasm in the campaign and are fully determined to stay by it until the full \$25,000 has been secured, Chest leaders assert. Because so many people are away from Wilmette during the ordinary business day, and because of the shortness of the period in which the canvass may be made, together with the many business and social engagements in the evening, contacting of all the prospects is more difficult than was at first expected.

In the campaign last year there was secured a total of about eighteen hundred different subscriptions. This year twelve hundred of these have been renewed up to the present time, leaving about six hundred still to be accounted for.

Campaign Continues

The campaign will continue during this week, or until all of these names are reported on.

It became apparent that at the rate of giving, these eighteen hundred prospects would not produce the full \$25,000, and so a special flying squadron is being organized by Village President Harry C. Kinne, for the purpose of securing additional pledges to the total of \$5,000 to insure a complete success. The workers have been greatly encouraged by this help and are redoubling their efforts to reach the \$20,000 expected of them.

Solicit Special Fund

The President's committee proposes to solicit and secure one hundred additional gifts of \$50 each to be paid only if a total of \$25,000 is not secured. The appeal for this special fund is made not only because of the pressing need for the full \$25,000, but also as a matter of civic pride, that Wilmette may take its rightful place with other north shore communities in meeting its budget of Community Chest obligations 100 per cent.

The workers are being met often by two or three objections that are being answered by Chest President Henry Fowler. One objection that is often encountered is that men are being taxed heavily in Chicago and so have little or nothing for their home community. Mr. Fowler calls attention to the fact that, while other communities may support the Chicago Chest and the residents of Chicago proper, and naturally do so, no other group will take care of Wilmette's charitable needs, and that, contrary
