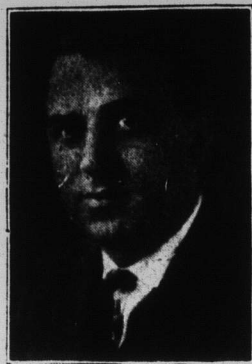


Benjamin Bills Is Dean of Brokerage Course at U. of C.

Benjamin F. Bills, Chairman of The Bills Realty, Inc., and other corporations in the organization, is dean of the case-study course in real estate brokerage which is being offered this summer by the National Association of Real Estate boards at the University of Chicago.

This real estate brokerage course is being offered under the sponsorship of the brokerage division of the National Association of Real Estate boards. At the same time at the University of Chicago there is also offered, likewise under the sponsorship of that association, a repetition of the course in appraisals which was first offered last year. During the summer, also, there is being presented at the University of Chicago a course in property management, under the same sponsorship.

The appointment of Mr. Bills as dean of the real estate brokerage course is generally recognized as a well-deserved honor. A brief review of his past activities which qualify him for this distinction includes, among other achievements, the following:

Instructor in Oral English, Williams college, Massachusetts, 1915; member of law faculty, University of Chicago, 1916-18; trust officer in charge of new business, Continental and Commercial Trust and Savings bank, Chicago, Illinois, 1919-22; director of sales and sales consultant of investment banking houses of Chicago, Middle West, and New York City, 1923-25; organized the Bills Corporations, including Bills Securities Corporation, the Bills Realty, Inc., 1926; head of the Benjamin Bills Organization; member of School of Commerce faculty, Northwestern university.

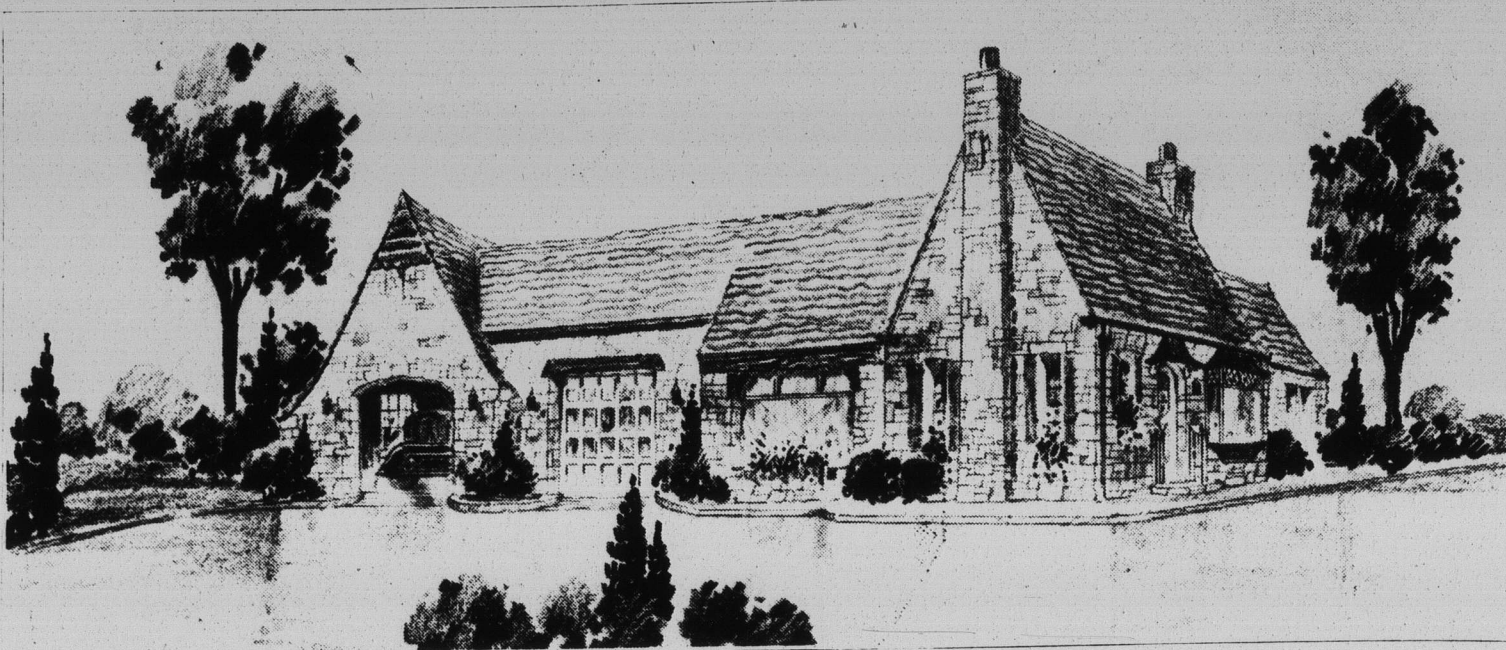

PURE OIL PLANS ATTRACTIVE STATION



Above is an architect's drawing of the proposed gasoline filling station which the Pure Oil Products company seeks a permit to erect at the intersection of Main street, Ashland avenue and Sixteenth street, Wilmette. The property is zoned "Class B, Commercial," in which filling stations and garages are not permitted under the Wilmette zoning ordinance. Action has been instituted in the courts to compel the building commissioner to issue a building permit, but trial of the case will probably not be reached until late in the fall.

New Chapel at Garrett to Be Place of Prayer, Meditation

Ground Is Broken; Construction Work to Start Aug. 1

Details of the new Frank W. Howes Memorial chapel, for which ground was broken at Garrett's commencement exercises June 10, were described this week by Dr. Horace G. Smith, president of Garrett Biblical Institute in Evanston.

The structure, which will cost approximately \$40,000, will be built of Bedford and limestone within and without and will follow the adapted Gothic architectural style used in the present Gothic building.

Designed primarily as a place for prayer and meditation, the chapel will be of small size, measuring approximately 16 by 40 feet, with the peak of the center gable rising about 20 feet.

It will stand in front of the administration building, slightly to the northwest of the main entrance and just to the north of the driveway leading from Sheridan road. Entrance to the chapel will be at the south end into a small narthax.

The chapel proper, with a seating capacity of 48 and accommodations for 12 more in the organ loft or gallery, will be dominated by a beautiful chancel, illumined through stained glass windows.

Architect Designs Windows

Henry Lee Willets of Philadelphia, one of the leading stained glass architects in the country, is designing the windows, which will have prayer as their central motif. Mr. Willets did the windows, also, for the Hilton chapel of the Chicago Theological seminary, a structure similar in type to that conceived by Garrett officials. There will be a central, dominating window, flanked on each side by three lancets.

The chapel is being designed by Holabird and Root, who were also architects for Garrett's present building. Plans are nearly completed, and it is hoped to call for bids in the near future and to let the contract before the middle of July. Construction, according to Dr. Smith, will begin about August 1.

Funds for the building have been donated by Mrs. Frank W. Howes in memory of her late husband, who was a Garrett trustee. Mrs. Howes turned the first spade of earth at the ground-breaking ceremonies.

Maps Tell Story of Big Vacation Travel

It is a long and heavy job this summer supplying the automobile road maps for the vacation trip of Mr. and Mrs. Johnny Q. Public.

It is so long that if the maps printed by Standard Oil Company of Indiana were unfolded and laid end to end they would cover 2,983 miles, or the distance from New York to Los Angeles, or a round-trip from Chicago to Miami, Salt Lake City, El Paso, or Glacier National park.
