

Comments on Prospects

"From the way inquiries are coming in, I would say the suburbs are going to experience a protracted period of new construction during which wages will continue to rise and building costs increase for some time, and the number of unemployed probably will be reduced as wage levels advance. Scarcity duced as wage levels advance. Scarcity of apartment space, rising rents and increased number of marriages, are fostering an almost universal desire to own new homes after the years of inactivity and doubling up, largely because the young family man, who used to live in a five or six room apartment in the city, can now build his own home in the suburbs and get his children out in the sunshine and fresh air and into the suburban schools with payments the same urban schools with payments the same each month, or less in many cases, than he formerly paid for rent.

"The tremendous improvements of the last few years in the facilities for automobile driving are a decided factor in helping suburban real estate. Lower tax rates in the suburbs in contrast to those in Chicago, where the relief load is so much heavier, are also favorable. Incidentally, speaking of transportation, according to the history of Chicago as we came out of past depressions some decided extension and improvement of transportation usually occured, and it is reasonable to expect something of that kind to happen again, I believe.

"I do not recall a time when there was as much winter building being done as is now going on. It looks like suburban building activity is just starting and there will be a further rapid improvement in real estate conditions as the pent up demand for new homes is
