Collection of 1938 Taxes Is In Full Swing

First Bills Sent Out by Collector Sanborn Hale on Saturday; Over \$30,000 Now in

Collection of 1938 taxes in New Trier township is now in full swing. Collector Sanborn Hale, Saturday morning began putting the bills in the mail, and with a force of 16 assistants, working at top speed, had all of the real estate bills in by Monday noon-over 18,000 of them.

He began getting the bills ready for mailing, Monday, March 20, and by Monday noon of this week the first returns came drifting in. At the close of business Tuesday, over \$30,000 had been collected.

Personal Property

He did not receive the personal property tax books until Tuesday afternoon, but said he would have these bills in the mail by Thursday.

He expects to have the books for a period of at least 21 days, and urges everyone to pay as promptly

"Many payments of both real and personal property taxes reach the township collector too late for him to record the payments before returning the tax books to the county collector," Mr. Hale said.

Delays Payments

"This not only delays the recording of the payments, but causes a considerable loss of time in the return of the tax receipts to the tax payer. If these payments reached the township collector promptly," it was pointed out, "a larger distribution of the tax would be available immediately to your local school, village and park district.'

Mr. Hale says that as soon as he receives definite information as to the extension of the penalty date. that is, if any is to be given, announcement will be made in this news magazine.

5,000 Year Old **Brick Donated** To High School

New Trier Township High school was the recipient this week of an archaeological treasure more than Six Protestant Churches Sponfive thousand years old, in the shape of an archaic brick from Ur of the Chaldees. Howard Miller, well known civic leader of Wilmette, was the donor, and this is the second time he has given similar Babylonian treasures to the rapidly growing museum.

The brick is uninscribed, of the plane convex type and is imprinted with two very deep-set finger marks. It was obtained by a joint expedition of the Museum of the University of Pennsylvania and the British Museum while conducting excavations at Ur. The date of the brick (B.C. 3500 to 3000) was determined by Dr. Leon Legrain, curator of the Babylonian section of the University of Pennsylvania and a member of the Joint Expedition to Ur during the years 1924-'25 and 1925-'26. The exact location of the find is known as Tell el Obeid and the time of the original building that of the First Dynasty of Ur. Thus the brick antedates the departure of Abram and his family from Ur by well over a
