

## Close Symphony Concert Season Week of April 17

The Chicago Symphony orchestra ends its forty-eighth season of concerts next week in Orchestra hall with four programs under the direction of Dr. Frederick Stock; the sixth of the Young People's on Wednesday afternoon, the twenty-eighth pair of Thursday night-Friday afternoon concerts and an extra special performance on Saturday night to be played at popular concert prices with the proceeds to be applied to the season's deficit.

Sold out last October, the Young People's programs given on the third Wednesday afternoon of each month, come to a close this week when some twenty-six hundred children of all ages will hear the orchestra play Abert's arrangement of Bach's Chorale and Fugue in G minor; the Andante con moto movement from Beethoven's Symphony No. 5; the Dance of the Nymphs and Satyrs from Schumann's "Amor and Psyche"; the Young Prince and Princess from Rimsky-Korsakov's "Scheherazade" and Elgar's Pomp and Circumstance. The song is Auld Lang Syne.

Climaxing a season which has brought a galaxy of instrumentalists, choruses and chamber ensembles, Dr. Stock will play the closing pair of Thursday-Friday concerts with no soloists. The program will consist of Beethoven's "Coriolanus" overture; Brahms' Symphony No. 1 and three excerpts from Wagnerian operas: the Prelude to Isolde's Love Death from "Tristan and Isolde"; "Brunnhilde's Immolation" from "Die Goetterdaemmerung" and the Prelude to "The Meistersingers of Nuremberg."

Previously unannounced, Dr. Stock will play an extra performance on Saturday night, April 22, for the benefit of the deficit incurred. The program will be played at Popular concert prices, and will consist of compositions by Beethoven and Wagner. The first half of the concert will be devoted to Beethoven's Egmont Overture and the Symphony No. 5; the last half consists of three excerpts from Wagner's operas: the Rainbow Scene and Song of the Rhine Maidens from "Das Rheingold"; the Prelude to Act II and the Ride of the Valkyries from "Die Walkure"; Siegfried Ascending Brunnhilde's Rock and Finale from "Siegfried."
