CONSTITUTION WEEK WILL BE **OBSERVED HERE**

Legion Post Enlists Co-operation of Civic Groups for Patriotic Program

Responding to an invitation from Wilmette Post No. 46, American Legion, the Wilmette Chamber of Commerce, the Wilmette Rotary club and the Wilmette Optimist club are joining with that organization of observance of Constitution Week, which begins on Monday, September 17. and continues through the week.

Preparations are now under way for a rousing public meeting on the evening of Monday, September 17. which is the 147th anniversary of the adoption of the constitution by the constitutional convention. Locally, it is expected that set observance of the week will be limited to this meet ing. Efforts are being made to secure for this occasion a speaker of national reputation, whose knowledge of the constitution and its history, as well as of the events which brought it into being, is complete, and whose address will be free of any tinge of politics.

Hayes of the American Legion that this nation-wide observance of Constitution Week was arranged, and the local program is part of that observance. Purchase Inhalator for Use at Bathing Beach

The Wilmette beach Thursday of last week installed an inhalator to be used for emergencies, in conjunction with the prone pressure method of artificial respiration. Lifeguards at the beach are being schooled in operating the inhalator which one man can carry in a valise to the scene of the emergency. The inhalator, equipped with two oxygen tanks, is regulated to prevent the oxygen from burning the lung tissue. Two extra tanks of oxygen, contained in a small valise, were purchased with the inhalator.

Adopts Resolution to Assist Commerce Commission: Rent Three Squad Cars

Action taken at a brisk session of the Wilmette board of trustees Tuesday night involved a variety of considerations including telephone rates, police transportation, highways, and street lighting.

In line with a letter received from the Illinois Municipal league by C. B. Cochran, chairman of Wilmette's public service committee, the Village board passed a resolution to help the Illinois Commerce commission in the proceedings now being undertaken in the investigation of telephone rates charged throughout the state.

Will Rent Police Cars

A current problem of police transportation was settled when the board decided to instruct the Village attorney to draw up a contract between the Ace Motor company and the Village of Wilmette for the hire and rental of three cars at \$7.50 per week a car plus two cents a mile per car for gasoline, oil and upkeep.

Wilmette's twenty-six remaining gas lamps, used for street lighting, are to go as a result of the board's decision Tuesday to enter into a contract with the Public Service company to replace these lights with electric bulbs and also to put new lights along Illinois road. The motion to replace the gas lights was passed, subject to cancellation of the present contract with the Welsbach Lighting company. In a communication regarding the problem, it was stated that the Village may save \$265 per year by replacing the gas lights with elec-

Expedite Traffic Flow

A thoroughfare that will permit a swift flow of traffic between Milwaukee and southern Illinois moved a legal step nearer completion when the board of trustees passed a resolution approving Plat 6-B, showing the dedication of the proposed S. B. I. (State Bond Issue) Route 57, as submitted by the county superintendent of highways to the president and board of Wilmette. A copy of the approved resolution will be forwarded to the county superintendent of later hold a confernce with President highways and the board of commissioners of Cook county.

Wants Village to Pay J. W. Nemoyer, resident engineer for Pearce, Greeley & Hansen on construction of the waterworks, addressed a letter to the board in which he asked that the Village pay for medical treatment made necessary because of impairment to his hearing sustained in making underwater inspections of the work.
