Kenilworth Board Ready to Set up Work Relief Plan

The Kenilworth Village board, at its November meeting Monday night, decided to go ahead with plans for setting up a new work relief program to take the place of a similar project, which expired on October 31.

The project finished by time limit at the end of October included the development of Mahoney park on both sides of Sheridan road at the south limits of the village, the improvement of the Village hall and fire station sites at Green Bay road and Kenilworth avenue, street, sidewalk and water repairs and tree surgery and tree planting. This work was started as a CWA project and when the CWA passed out of existence last March the work was continued by the village under the Federal Emergency Relief administration. All men employed were on federal relief and their salaries were paid by the federal government. Whatever projects of this kind are undertaken in the future are to be continued on this basis.

The finance committee of the Village board, of which Trustee Chase Love is chairman, will work with a committee from the Kenilworth Park board in making plans for the work relief program.
