SCHOOL BOARDS WILL BE CHOSEN THIS SATURDAY

Non-Partisan Slates Unopposed on Wilmette, Kenilworth, **High School Ballots**

Members of the boards of educations of the school districts within New Trier township will be elected this Saturday afternoon. Polls will open at noon and will close at ? o'clock.

Non-partisan slates in all districts will be unopposed.

Only one member of the high school board is to be chosen. Otto Raymond Barnett, 684 Greenleaf avenue, Glencoe, is seeking re-election. He has served since 1929.

Irregular Shape
The Wilmette school district, irregularly shaped, includes No Man's Land, along the lake shore, as well as a portion of the village of Glenview east of Harms road and south of Wilmette avenue, near the Glenayre

Other portions of the village, principally the section lying north of Wilmette avenue and west of Hibbard road, Ramona road, and Pine street, as well as the 1300 block on Chestnut avenue, are outside the district.

The polling place for the entire district will be the gymnasium of the Byron C. Stolp school, 718 Tenth street.

Names which will appear on the ballot will be: Henry J. Brandt, 816 Forest avenue, for a term of one year as president; Mrs. Margaret T. Marmaduke, 230 Laurel avenue, and Mrs. Mary Drucker, 1125 Mohawk road, for terms of three years.

Nominations were made by a caucus of delegates representing a number of civic organizations, including the two Parent-Teacher associations, the Civic league, the Chamber of Commerce, the Woman's club, and the Northridge Woman's club.

Kenilworth Board Two positions are to be filled on the Kenilworth board of education. George H. Rigler, 706 Cummings avenue, and John J. Krause, 123 Oxford road are the nominees for term

of three years. The polling place will be the gymnasium of the Joseph Sears school, Cumberland avenue and Abbotsford

The Kenilworth district includes the entire village of Kenilworth, as well as all of the village of Winnetka south of Winnetka avenue, and the 1300 block on Chestnut avenue in Wil-

Nominations were made by the Kenilworth advisory committee, whose members include representatives of the village's taxing bodies, civic, welfare, and religious organizations.

Assessed Valuation of Personal Property Shows Increase: Start Collections Soon

New Trier Township Tax Collector. Sanborn Hale has received from County Clerk Michael J. Flynn, real estate and personal property valuations, and the rates, on which the 1937 tax bills are now being extended and which will be placed in collection in the next few weeks.

The total assessed valuation in New Trier for 1937 is \$59,730,359, as compared to \$51,719,690 for 1936.

The total assessed real estate valuation for 1937 is \$16,887,169, as compared to \$41,992,447 for 1936, whereas, the personal property assessed valuation for 1937 is \$16,887,169, as compared to \$9,229,076. In the railroads, the assessed valuation for 1937 is \$485,484, and it was \$498,167 for 1936.

Compare Rates

A comparison of total tax rates for the four north shore villages of Wilmette, Kenilworth, Winnetka, and Glencoe, show that the 1937 rate for Wilmette is 6.11, as compared to 6.02 for 1936; Kenilworth, 5.17 for 1937 and 5.25 for 1936; Winnetka, 5.94 for 1937 and 6.07 for 1936; Glencoe, 6.54 for 1937 and 6.72 for 1936.

There will be some slight variation in total rate, however, due to the fact that park and school district boundaries are not coexistant with village limits.

Violators of Dog Ordinance Facing Police Summons

Chief of Police McGuire stated Tuesday night that summons are now being issued for all owners who permit their dogs to run at large. Some thirty arrests have already been made, and it is said that the campaign will continue until the nuisance is abated.

The Village regulations provide that all dogs must at all times be kept securely confined on the owner's property, and taken on the street only on leash.
