THE INTERCOLONIAL RAILWAY. The Press has freely discussed the merits of this scheme, and as it is now indefinitely postponed, we deem it proper to lay a few of the facts before our readers.

Although the Intercolonial Railway project is postponed, it would be wrong to say that the mission of Mr. Scott and Howland to England, in relation to it, has resulted in its abandonment.

Two other conditions, insisted upon by Canada as essentials, were objected to by the Home Government. One is, that the provincial contribution toward the construction of the railroad shall be accepted as a contribution toward provincial defence.
