THE NOMINATIONS. SOUTH VICTORIA

The nominations for the local legislatur took place Monday all over the province. Four ministerialists were elected by acciamation: Hon. O. Mowat, Mr. Jas. Young for North Brant, Mr. O'Connor for South Bruce and Mr. Neelon for Lincoln; and one for the opposition, Mr. Meredith.

The South Victoria proceedings at the tows hall, Lindbay, were quiet. There was a fair gathering of electors, mainly from the town. At one o'clock Mr. P. Mitchell the worthy deputy-sheriff, read the writ and opened the ball. Mr. Fairbairs was nominated by Mr. A. McQuade, seconded by Mr. John Kennedy. Mr. McIntyre was nominated by Mr. Jno. McLennan, second ed by Mr. John Connolly of Ops. There were no other nominations. After the hour for formal proceedings had expired Mr. Mitchell was on motion appointed chairman and the candidates were called on to address the electors.

Mr. FAIRBAIRN, who was applauded on taking the platform, said he was a true conservative and had been for twenty vears. He did not think it was necessary to enter into detail regarding the different charges he had against the Mowat adminintration, as it would be quite out of place in this connection. He professed a desire to avoid personalities and said he would fight his opponent on the public questions of the day, and then proceeded to claim that he would compare favorably with Mr. McIntyre, that he would guard and protect their interests, and that though he might not have as fine an education as Mr. McIntyre he claimed to have good common Intyre he claimed to have good common sense, and much more practical experience. He was therefore capable of presiding over their deliberations just as well as Mr. Mc-Intyre. He had been a poor roung man; his father had had more sons than he had had farms. In Mr. McIntyre's case the boot was on the other leg; Mr. McIntyre's father had had more farms than he had sone; and he argued from this that he (Mr. sons; and he argued from this that he (Mr. Fairbairn) was better fitted to represent South Victoris. He bossted that although he was a stranger in Ops and Mariposa he had met with a most cordial reception, and he wassure of his election (applause); it was merely a question of majority with him and he called on his supporters to make it a large one. (Applause and laughter.)

After expressing his sense of the honor con-ferred on him by the nomination, Mr. Mc Intyre said he was pieased to hear his op-ponent profess a desire to avoid personali-ties. He and his friends had done so and would continue in that course. He regret-ted Mr. Fairbairn had not here on the hustings formulated the charges he had in private and on the platform at his own neetings made against himself and the Mowat government, especially in connection with the railway amalgamation. (Applause.) Mr.McIntyre then referred to the action taken by the county council in the railway amalgamation matter last winter, and read from the report adopted by that body (printed on our editorial page), and pointed out that he had, though not a not do for the town to say they would not or pose amalgamation if they got a bribe. He had asked Mr. Grace if one member of the opposition would on the floor of the house advocate his demands, and not one would do so. He claimed that neither he nor the government had sacrificed the interests of the town or county; and pointed out that the bill was a private bill and not a government measure Mr. McLityre's remarks were frequently applauted. Mr. McIntyre then briefly replied to Mr. Fairbairn's remarks about his farms, and in a few eloquent words disposed of the inuen-does in a way that called forth warm applause. He proceeded to contrast the policy of the opposition with that of the government so far as farmers were more immediately concerned, and shewed that firmediately concerned, mers in their own interests should support the Mowat administration and their candidates. (Cheers.) He pointed out that Mr. Fairbairn in his address had gone in or universal suffrage; and said that while he (Mr. McIntyre) would support a very considerable extension of the franchise he would oppose any scheme which would confer it on gamblers, on those who had no visible means of support, on trimps or on the criminal classes, but only on those who were sober, industrious, law abiding and intelligent. He next alluded briefly to the license question and to the fine fina. ciol record of the administration, and in concluding said he would not, like his opponent, indulge in boastful predictions about the result of the contest, or whistle to keep up the courage of his supporters. (Cheers.) He was confident he would r. ceive hearty, vigorous and active support all over the riding and he was satisfied to

abide by the result. (Cheers.)

Mr. FAIRHAIRN cam: forward and after referring to the work of the railway companies said the report of the committee of the county council (prepared by Mr. Robt. Adam) was a white washing report. He charged the government with white washing as well. As to himself he reterred to the report adopted the previous December


