This time I gave another day to bring the excuse. and one of them, authorized by his father, brought me the following:—"Papa kept me me to drive the ducks to water." Knowing it was intended as an insult, I suspended the boy, after which Mr Marshall saw the trustees, and requested that a meeting be held the following Friday, which request was granted and the meeting duly attended by all excepting Mr. Marshall. Owing to his absence the meeting was adjourned until a week from the following Monday Seeing the rebellious course which Mr. Marshall seemed determined to pursue, ! acted on the advice of friends and proceed ed to have him prosecuted according to law for his abusive conduct on Jan. 29th, lest he might repeat it. At his trial he corro-borated and signed before a bench of four magistrates the evidence I gave, and was, as he says, "acquitted by being fined one dollar and costs."
