A somewhat interesting debate took

place in the house recently on the motion of Mr. Woodworth, a building toy master from Nova Scotia, for correspondence between the Conservatives and "one" Arthur Penn, publisher of the *Whig Times*, claiming to be the "organ" of the government in that part of the Dominion. The Times has been virulent and ably condemning the new tariff policy of Sir Leonard Tilley and Mr. Woodworth was determined to bring the organ to life. He did his work so ably, however, that he had a sharp disagreement with Mr. Mackenzie Hogg, whom he accused of being "infected" in the Times. The organ brought a few words from Sir John Macdonald, who found it convenient for the nonce to commend little independent, but now and then, and to give a severe and caustic hit now and then ungratefully at those party organs who belittle him with pride and render him unequalled and abject support. Mr. John said "he did not care for the supports of journals which from their tone showed themselves to be subservient organs that were prepared to give a virulent approval of every thing the government did. Such journals were clearly valuable from a party point of view." This was a hard hit at the *Whig*, and that in connection with the well known fact that the editor of the *Whig* is Sir Charles Tupper's protege if he has some significance. Help it fact, caustic Mr. John striking the epithets out, and the world will realize of the tory party will be handed down to posterity as "Tupper's dog."

TROUBLE AT REGINA.

All is not lonely and serene at Regina. The Whig paper have been running down the new metropolis of the West, and the Regina Leader says their column is "unmerciful and even infamous" in declaring "they are nothing better than mere trumpets, without regard for truth, for honor, for morality." It urges the Reginaites to "burn their boats," which would be a very rash thing if that well should overflow or the rugged Waggon indulges in a freak, and calls upon them "to do or die," and thereby make Regina one of the finest cities in the continent. To this end "every weak-kneed and blackguard" about "gets out," and left only "men and women of faith and purpose and patience" remain. That is the grand old spirit, and it demonstrates to a cold and calculating world, abhorred to the lip, its philistinism, that the noble enthusiasm and faith of our forefathers has not died out, but has taken fresh life in the great and fertile west.

EDITORIAL NOTES.

Supplementary estimates amounting to \$1,700,000 have been brought down, making the estimated expenditure next year over \$60,000,000.

Sir John Macdonald has introduced the Income Bill after all. It is long enough to keep the house three weeks in session, but the ministerialists will take it all down at one go.

"The entry wash" game at Ottawa having been defeated, it is now proposed to prolong the session well into June in order that there may be more alleged ground for the increase.

The Proconsul and Mr. Helen's Reporters (King) announced the arrival at Liverpool of Mr. W. H. McNaughton, special immigration agent of the Ontario government, and speaker very highly of the appointment.

The clash of the special license committee at Ottawa states that Prof. Foster, M.P., did not give his approval to the plan for selling liquor at three periods on Sundays, as reported in several papers.

Sheriff Wardell of Cobourg, who has long been in declining health, has placed his resignation in the hands of Mr. Mount, Mr. W. H. Burke, ex-M.P. for West Durham, is mentioned as likely to be the successor.

Mr. Wood has retired from the local government. His succession is not yet settled, but it is not believed Mr. Hardy will go to the treasury department and that Mr. Isa. Young of Galt will take the provincial secretaryship.

An order was obtained last Friday before Justice Patterson at Osgoode Hall on behalf of the respondent for particulars of the history charged in the petition filed in the North Victoria election case. Similar steps have been taken in a number of contested cases.

Hon. A. Macdonald was recently presented with a purse of ten thousand and odd dollars by some Ottawa and Eastern Ontario friends and admirers. He sailed for Europe in a few days for long holiday, and the country will hope that he may be fully restored to his old vigor.

The statutory statement of the expenses of candidates in the local elections are now appearing in the papers. In South Victoria the expenses of Mr. McIntyre were \$60,115; Mr. John Bell, North Victoria, \$64,40; Mr. Glentle, North Ontario, \$60,00; Mr. Ferguson, East Durham, \$17,000.

The Warter has made a move of its own, and one that may lead to serious consequences. It has had the bad grace to comment on the first case of Mr. Rodger's. This does in a way that may render it liable for contempt of court. It is strange that our contemporary was not aware of the impropriety of its course.

Sir Chas. Tupper has brought down resolutions granting authority to raise \$100,000, amounting in all to \$1,100,000. Among them is \$60,000 to the Niagara and Tonawanda railway. This is the price paid for the rejection of Mr. Donisthorpe by Addington. The railway from Graves-Hamilton to Calender goes \$10,000 per mile for 110 miles in addition to a former grant.

A protest has been entered against the election of Mr. Paquet, the conservative candidate for Muskoka, and some stock exchanges may be expected. Mr. H. Smith, the other tory organizer, has obtained a return to Europe at the public expense, so as to be out of the way of awkward enquiries in this or any other case. The lawyer will reap a rich harvest this summer among any of the thirty odd election cases awaiting trial.

Hamilton Times: Mr. D. B. Hay, ex-M. P., has been presented by his liberal friends in North Port Hope with a letter of address and a purse containing \$100,000 on the occasion of his departure from Lindsay. He goes to Great Britain as a representative of Ontario, and will devote his energies to securing sound financial and domestic reforms for the province.
