ments proposed by the hon senate to exempt wine, beer and ale from the operation of the said act be not concurred in, be received and read a first time.

Mr. FAIRBAIRN said he did not want to hit the senate of Canada a slap in the face by asking them to take back what they had done. He thought they were as wise as the county council and knew what they were doing.

Mr. Evres said it was not propos give a slap at the senate, but merely to give an expression of opinion as to what we considered fair and right. The people of many counties had taken hold of the Scott many counties had taken hold of the Scott act in good faith and in a popular vote of about 200,000 it had been carried by a majority of about 46,000. The senate amendments entirely changed the character of the act and he thought it was in accordance with the principles of British fair play that the act should have a fair trial. Mr. Eyers read the memorial as follows:

That nearly one-third of the whole number of qualified electors of the county of Victoria, in the exercise of the rights and privileges granted them under the provisions of the Canada temperance act of 1878, have signed a petition to his ance act of 1878, have signed a petition to his excellency the governor-general in council, praying that the second part of the said act should be in force and take effect in the said county of Victoria, and that the votes of all the electors of the said county of Victoria be taken for and against the adoption of the said act.

That the honorable the senate of the Dominion of Canada, by seeking to excempt wine, beer and ale from the operation of the said act, have so amended it as to completely destroy it as means of prohibiting the sale of intoxicating liquors within the counties and cities in which it has been adopted by majorities aggregating 46,000 out of a total vote of 200,000.

That in the event of the amendments referred to becoming law the will of the electors who have already adopted the said act would be overborne, and an enactment would be unjustly forced upon them, which in principle is directly opposed to the law which they have adopted by such striking majorities.

That the concurrence of your henorable house in such a change in the said act as the amendments made by the senate would effect, would have a decided tendency to weaken the confidence of the electorate of the Dominion in the highest representative body in the country, mere especially as already during the present session your honorable house has rejected by a large majority an amendment offered for the purpose of making a change in the character of the said act similar to that which would be caused by the amendments hereinbefore referred to.

Your petitioners therefore humbly pray that your honorable house will not concur in the said amendments but on the contrary will preserve to the electorate of the Dominion the unquestionable right to choose for themselves whether the Canada temperance of 1878 in its entirety shall or shall not be the law in the respective counties and cities, and that no change may be made in the said act to impair its character as a prohibitory measure.
