

DEATH OF COL. WILLIAMS. THE BERO OF BATOCHE SUC-

CUMBS TO BRAIN FEVER. Only Two Days Ill-Details of the Sad

Valliquet, No. 6 company, Sixty-fifth Battalion. The former complained of illness on Sunday at church parade, and imagined he had been the victim of a slight sunstroke. The camping ground at Pitt being damp, he removed on Tuesday to the steamer, where he received attention. He rapidly became worse, and on Thursday he became unconscious. THE SENATE AND THE SCOTT

The Seer and Light Wine Clauses Sent

Back to the Commons Again.

The senate have decided to insist upon their amendments to the bill amending the Scott act and the bill will be sent back to the house of commons with the wine and beer clauses restored. The question came up in the senate last Monday evening. Sir Alexander Campbell undertook to champion the anti-temperance clause. Mr. Vidal moved that the senate should not insist upon its amendment striking out the clause imposing penalties upon doctors, magistrates, and others for granting liquor certificates improperly. Sir Alexander Campbell advised the house to adhere to its course of a few days ago. The house of commons had not given sufficient reason for restoring its penalty clause as the act already provided for the punishment of persons violating the act. It would be an outrage to have doctors and clergymen dragged summarily before any seat of a justice of the peace to answer charges of granting certificates for liquor improperly. Sir Alexander's motion that the senate should insist on its amendment was carried by 15 to 30. Mr. Vidal then moved that the senate should not insist upon its wine and beer amendments. Sir Alexander Campbell moved that the amendment should be insisted on, as the reasons given by the house of commons for rejecting the amendment were unsound. This parliament was not were unsound. This parliament was not bound by the act of any preceeding parliament, and those cities and counties which adopted the Scott act had no right to assume that it would not be repealed for three years, so that there was no compact to be broken. This parliament was free to do as it pleased in the matter. The house of commons had misrepresented the law because all that was provided was that no executive action should be taken to repeal executive action should be taken to repeal
