Chancellor Boyd's Decision—In Favor of the School Board—The Mandamus Granted with Costs. [Specially reported for THE POST.]

On Friday last, 27th April, the Chancellor gave judgment at Osgoode hall upon the motion of the Oakwood high school board for a mandamus to compel the municipal council of the township of Mariposa to raise \$4,000 for the purpose of a new school building and site, which was argued on the 24th April. His lordship's judgment was in favor of the school board and waslas follows:

The effect of legislation is to withdraw the village of Woodville from the high school district of Mariposa. By the statute. 47 Vic., cap. 62, that village is constituted a corporation separate and apart from the townships of Mariposa and Eldon, in parts of which it was situated (sec. 1): and by sec. 9 it was declared that the village shall'cease to form part of such townships and shall to all intents and purposes form a separate municipality, with all the rights, privileges and jurisdiction of an incorporated village in Ontario. Among these advantages was the right to have a high school apart from the township by virtue of R. S. Ont. (1887), cap. 226, secs. 4 and 15, etc. Therefore I give no effect to

this objection. As to the other matters argued, the Napanee case, 29 Graut, seems decisive against the objections urged by the municipality, if the substance and not the form of the transaction is regarded. Before the 1st of August the school board made application to the council for a grant of \$4,000 for school purposes, and asked further the privilege "to build the new building conprivilege "to build the new building contemplated on township property south of the township hall, together with the use of the grounds in the rear thereof as a playground." This application was negatived by 4 to 1 at the meeting of the council held on 18 h July, whereupon the school trustees present at the meeting said they would forego their claim to the benefits sought over and above the \$4,000, and would at the next meeting bring forward a by-law for the money grant alone. They did so at the next council meeting on 8th August, when the by-law 352 was voted on with the result of 3 against and 2 for. This by the statute R. S. Ont. (1887), cap. 226, sec. 35, was not a refusal of the application, and by the interpretation put upon that section by the interpretation put upon that section was an acceptance of the requisition. Before the passing of the original of this enactment the municipal council had no option to reject, but were under parliamen tary obligation to raise by assessment the amount required for school purposes, even though the money was to be applied to-wards the erection of a new building. Niagara case, 1 appeal reports 288; and Stormont case, 45 Upper Canada (Q.B.) reports, 460. The present legislation relieves them from this accessity only when there is "a two-thirds vote of the members pre-

sent at the meeting of the council for considering any by-law in that behalf."

Upon the rejection of the application as originally framed no doubt the school trusoriginally framed no doubt the school trustees could have elected to request the council to submit the matter to the vote of the ratepayers; but they were not shut up to this course. They could (as they did) renew the application in a modified form and so reduce the opposition of the councillors as to obviate any appeal to the electors. The council might perhaps have refused to consider the matter in a modified. refused to consider the matter in a modi-fied form, and have insisted on an appeal to the electors, and under sub-section 4 of ection 35 they could afterwards have receded from this position and have acted as they did, i.e., pass the by-law because of their inability to procure a two-thirds vote against it. A by 'aw is probably not essential, but it is the usual course adopted, as the statute recognizes and intimates, and such a by-law, if not negatived by a two-thirds vote of the council, fixes the municipal district with liability to raise municipal district with hability to raise the amount required, which cannot in my opinion be repealed, as in the case of an ordinary by law, before it is acted on. The failure to reject by a two-thirds vote concludes the matter unalterably against the control and the obligation then becomes council and the obligation then becomes, as under the former law, absolute and

imperative.

The applicants are therefore entitled to raise a mandamus upon the council to raise forthwith the \$4,000, and to the costs of their proceeding in the court.

taken on the Scott act bill in the commons early Thursday morning Sir John Macdonald walked up and chatted a minute to Mr. Speaker, and then, being next the door, shot out and shirked the vote. He voted on the prohibition motion and against, and Mr. Jamieson knew it. The canting hypocrite stood convicted of wilful misrepresentation and had to apologize with bad grace to Mr. Mills. His statement that Mills had vacated the chamber with the speed of vacated the chamber with the speed of Maud S. he admitted was a figure of im-

Mr. Bain of Wentworth made a most telling speech on the temperance question last Wednesday night, to which the whole house listened with the closest attention. house listened with the closest attention. His exposure of the way the conservative temperance electors were being humbugged by such men as Jamieson and Foster was most expressive, and the house on both sides hugely enjoyed his description of Foster as a man warmed into his seat by a cause which he now damned with his silence. Foster did not once speak during the debate.
