If people are slowly poisoned they are no less put to death than if a foreign foe did the killing.

And that this water has its yearly victims is an unquestioned fact. The slow death does not strike the mind with the shock of murder, but the dead victims are there all the same.

It is the duty of the government of a country to protect the lives of the people and next after that to protect their properties. You were elected to perform your share of this duty. Your attention has been called to the evils caused to your constituents by the present condition of the Scugog waters. It might reasonably be left with you to find out and apply the remedy.

Having put my hand to the plough I am not going to turn from the furrow. Whatever assistance I can give or what information I can reasonably procure you shall have, but I object to the expression at the conclusion of your last letter, that if I answer your questions I have made out my case. It is not my case—it is everybody's case.

The sources from which Scugog river and lake drew a supply continuing all the year are gone forever. You admit that; everybody admits that.

That is the foundation stone. Now what are we to build? "An impervious dam that will keep the water at a uniform height," say the delegation. Well, sir, this is impracticable and impossible unless they reconstruct nature and prevent the spring freshet and the summer drought. No doubt the waters could be raised, and as a consequence additional land flooded. Leaving the question of cost and compensation aside, do you, sir, think this would benefit the health of the community?

What is the other proposal? Simply to leave the river as nearly as we can as the God of nature left it; and with all respect to the wisdom of the delegation I prefer His workmanship. You can in places see the natural bed, stoney and clean, and the shore unnaturally submerged, boggy, dirty and sickening. It does not require either the eye or the nose of an expert to find that.

I cannot answer your very comprehen.

I cannot answer your very comprehensive questions much more satisfactorily than I sought to do in my former letters. I am not as well acquainted with the lake as I am with the river and crocks. I know land from which the water has gradually receded. It is now first-class land. I receded. It is now first-class land. I know other lands never actually submerged but which formerly could not be drained, which now in these later years have been improved fifty per cent. by the additional drainage afforded by the falling of the river in the earlier summer. I know one farm on which the government surveyor found that forty-five acres of good land were submerged by the building of the dam. Is it not reasonable from the knowledge of these facts that I draw the conclusions which I have done?

SIR,-For the want of time I have not been able to reply to Mayor Walters any sooner, in answer to the attack made upon myself and the Lindsay press for presuming to criticize the Lindsay press for presuming to criticize the mismanagement of our town affairs for the last two years, whereby our taxes have been increased until it has become a burthen, or in fact a rent instead of a tax. A few more year's mismanagement like the past two and our town would be bankrupted. Our council has been making one continual chapter of blunders which is worse than crime. It shows there is not one good level headed, honest business man in the lot to guide or advise them. Our mayor need not think that he is going to bulldose myself or other ratepayers into silence and let heir blunders pass uncriticised. When he cound there was an outcry against their squandering of the people's money why didn't he pring a true statement of what had become of the people dering of the people's money why didn't he bring a true statement of what had become of the town funds and how the taxes are so high. Instead of that he read a scurrilous sheet of abuse against mysel' and others to the council on the 17th September, and under the protection of his office and the town constables refused me an opportunity to reply to his insinuations. But it is not too late for Mayor Walters to bring in a report showing what has become of the people's money and how it is the rate is so high. If the mayor and council fail to report on the matter and give the required information at the next council meeting that the ratepayers are demanding then I as a ratepayer shall make the report for them, and may be it wil create a bigger fuse in the council board than my last letter did. I find there was a rate struck to raise \$38,500, and I also find that we have to pay out of that as follows: \$10,700 debenture interest; \$12,000 school taxes: \$2,500 county rate; \$460 for street watering; or in all \$25,660, leaving a balance to be accounted for of \$12,840. Now, what I am after is to know what has become of this latter amount? If the curiosities bought this year cost only a legitimate price, then where is the money gone to?
