Still he struggled along against poor crops, low prices for produce and high rates of interest, in the hope of seeing better days, but the odds were against bim, and this fall some of his creditors wanted principal and interest faster than he could make them, when his courage seemed to have failed him and he went away without an intimation to any one of his doing so. So soon as he had gone stories were originated and circulated without stint. Eager ones, anxious to get without atint. Eager ones, anxious to get their own, visited the farm, and as his son was unable to give money, he parted with cattle to one and horses to another of his ather's creditors till nothing was left. This was a mistake, of course, as the pro-perty will have to be returned, and legally disposed of under an assignment, or otherwise, as the law directs. So far as we can learn the doctor has done nothing of a criminal nature. He may have been and no doubt was mistaken in his estimate of the quantity of grain he had, but he did not sell the same to two buyers, nor did he raise all the money he could get, and carry it away with him. His heaviest creditors express the hope that he may be induced to return, make an assignment, and thereby prevent needless litigation, and save something for his creditors.
