COMMERCIAL NEWS.

OFFICE OF THE CANADIAN POST, LINDSAY, Nov. 28, 1889. The Victoria and Peterboro Cheese Industry.

At the request of the Peterboro Examiner, Mr. Warren Taylor, the efficient secretary of the cheese board, has furnished a succinct summary of the operations of the year. Mr. Taylor say :-

Thinking it might be of interest to the readers of the Examiner to review the business done through the medium of the cheese board. I give the following summary: In 1884 there was made in the county in 14 factories, 13,201 boxes of cheese, which sold for about \$79,200.

FIN 1888 the make in 19 factories was 19,-280 boxes worth \$115,000, an increase in

the interval, of 600 bexes and in cash of \$35 800, over the year 1884. The make for the present year, 1889, in 15 factories was 20,681 boxes, worth \$124,-000, an increase of 1,400 boxes and \$8,400 over 1888, and 7480 boxes and \$44,880 over 1884. Not including two factories which did not sell on the cheese board this year.
The make in Victoria county for present year was 4354 box s worth \$26,000.

The total make in Peterboro and Victoris counties this year would be worth about \$150 000. Your readers may say that is a vast amount of money; I would ask them what are the possibilities in the dairy business? Could the farmers of these two countles not vasily increase the returns for dairy produce if they should try! If they would sow clover freely and raise more rough grain and grase, and grow fodder corn and store it in the silo, select and keep the best stock, provide good stabling, and keep stock comfortable, they may keep cows milking nine or ten months in the year, and thus make the land flow with milk and -money. Besides stock keeping is the way to increase the fertility of an exhausted soil; but it farmers will in trving to grow grain without sufficient barn room, then thresh in the harvest time and put the straw in an ill built stack to remain there through the rains of the autumn, then to free z ; and then expect the poor cow to live through the long, cold winter on the straw stack, while the grain is all taken to market, verily their profits Rather let the motto be, will be small. move forward all along the line. - Yours WARREN TAYLOR, S cretary.

Toronto Live Stock Market. There was a small run of stock at the local cattle market Wednesday. The receipts were 19 loads, including 150 sheep and lambs and 50 hogs.
