ECHOES FROM THE CAPITAL

TWO-ROWED BARLEY SEED. The order has now been forwarded

for the two-rowed barley, which the government is to import for seed for farmers desiring to grow this crop for exportation of the English market. Ten thousand bushels have been ordered and will arrive about the middle of March. They will be distributed in two-bushel lots, and each farmer sowing this quantity will have from it all the seed he can possibly want for next year.

Experiments with an improved variety of oats have been made by direction of Professor Saunders of the experimental farm in various parts of the country with various satisfactory results, and a recommendation to farmers to substitute the new variety is likely to be made shortly. REBATE ON CORN.

Mr. Laurier's amendment in favor of abolishing the rebate of duty given to distillers on corn imported and used in the manufacture of spirits for export, was lost by a vote of 69 yeas to 104 nays. It was a straight party division, with the exception that Mr. Kirkpatrick and Col. O'Brien voted with the opposition. The Globe's gallery correspondent says: The government succeeded in finding a pretence on which to vote down Mr. Laurier's motion to abolish the rebate allowed to distillers on corn imported for use in the manufacture of spirits. It is well understood that the supporters of the government were as used that the matter would be considered in the tariff measure to be brought down at the later stage of the session, and it was on the strength of this promise that the motion was rejected. The vote was 104 to 69 against the resolution. Mr. Kirkpatrick, Mr. Peter White, Mr. Jamleson, Col. O'Brien and Mr. Alonzo Wright voted with the opposition. perfect national policy. THE WAR MINISTER'S WRATH. When the vote for contingencies for the militia department was reached, Mr. Somerville asked the minister how he had spent the sum paid for travelling expenses. Sir Adolphe Caron said that he had spent the amount charged for travelling expenses in the interest of the country. Dr. Wilson said that the explanation was not satisfactory. The chairman called upon Sir Adolphe to withdraw his offensive remarks. At first he refused, but the stern command of the premier caused the war minister to calm down, and he made a retraction with very bad grace, prolonging his speech to such an extent that the voice of his leader erdering him to "sit down," could be heard all over the chamber. Dr. Wilson replied forcibly, stating that he was not going to be terrified by the war minister's outburst of temper. Sir Adolphe was pressed for further explanations but he would not trust himself to address the house again, and Mr. Lister in a powerful speech said that the position of the minister was that of a man who had spent public money and refused to account for it.
