The meeting would have taken place before this had not circumstances prevented; but there is still time for thorough organization and preparation for the coming struggle, which is likely to be one of almost un precedented obstinacy, and it is to be hoped that when the representative men of the party come together they will engage in the work before them with the zeal and energy that invariably characterize the movements of their opponents

The Trial of Guiteau.

The trial of Charles J. Guiteau for the murder of President Garfield commenced over two months ago and is still in progress, but the probabilities are that it will not last many days longer. It has been one of the most extraordinary affairs of the kind on record, and in the opinion of the civilized world is a disgrace to the nation. prominent English lawyer some weeks ago expressed his astonishment at the farcial nature of the trial, and said that in Britain it would have been begun and ended in a day, as the assassin was taken red handed and the plea of insanity would not have been listened to for a moment; but they treat murderers differently in America, where so many of them escape on one pretext or another that it would be better to abolish capital punishment at once and substitute therefor a penalty that could be discontinued the moment it was believed to be wrongly inflicted. Guiteau himself wisely denies that he is or has been insane, and boldly affirms that he was inspired by "the Deity," who compelled him to "remove the President, in order to save the country from civil war; while the counsel for the defence assert that the prisoner's belief that he was inspired is a direct proof that he is insane, and on this ground they claim a verdict of not guilty. According to last accounts, an impression prevails in the States that Judge Cox thinks that Guiteau is insane, and that the jury are likely to disagree, especially as one of them is said to belong to a family in which there is insanity, and will, therefore, probably sympathise with the criminal. Whatever opinion those ex-CANCER CURED traordinary people in the States may entertain with reference to Guiteau's mental condition when he shot the President, the belief elsewhere will be that he was fully as sane as the average American; that he knew full well the criminality and illegality of the act that he was committing, and that nothing short of the direct interposition of "the Deity" should be allowed to save him from the gallows. It is often urged that "it is better that a dozen murderers should escape than that one innocent man should be hanged;" and whether this be true or not, it is undeniably true that it is better to hang an innocent man than that a dozen innocent ones be shot, and there will be no end of shootings and assassinations by other means if Guiteau be acquitted

ATTEMPT TO POISON AN OLD COUPLE WITH STRYCHNINE.

morning last Dr. Bonnelle was called to attend an old couple named Stewart, living about four miles from here, who had been taken suddenly ill. On going out he found they were both suffering from a dose of strychnine. Suspicion pointed to one Wm. Mounteny, whom Dr. Bonnelle had arrested. The facts are that Stewart had a sum of money in the house to pay his rent with, and had asked Mounteny, who had been out there, to call and tell his landlord; but Mounteny, instead of doing so, procured two bottles of whisky, one of which he charged with strychnine, and went back to Stewart's in the afternoon, giving each of the old couple a drink. In the evening he concluded to stay over night, and before going to bed invited the old couple to take a drink before retiring. which they at first declined, but after pressing they each drank, Mounteny drinking out of another bottle. They all then retired. As soon as Mrs. Stewart got to her room she fell in front of the bed with convulsions, saying that she was poisoned. Mr. Stewart ran to the nearest neighbour's, and on returning fell himself in front of the stove with convulsions. Emetics were given to both and Dr. Bonnelle sent for. They are both now out of danger, having had a very narrow escape. The bottle containing some strychnine was found in a field the next day. The evidence was clear against Mounteny to-day, and he was committed to the Lindsay gaol to stand his trial.

Violation of the Game Laws. A correspondent of the Ottawa Fre Press complains that the game laws ar not properly enforced on the Upper Ot tawa. He says : - It is really a shame to see the wholesale destruction of moose and small deer through the winter, when they are so easily hunted down. They are not near so numerous now as they were eight or ten years ago. It the game laws were enforced for two or three years they would again become quite numerous. The Indians, not content with killing enough to meet their own wants, have got into the habit of offering the meat for sale at the depots ind shanties convenient to them, they will not travel far with their loads. Their usual method is to hunt down and kill the moose, and then move camp to where the carcuss is, where they remain until they have it caten The Indians in this upper country are no exception to the rule, being lazy and shiftless, never providing for more than day or two at a time.

The Latest Fraud.

Quebec, Jan. 13 .- A great fraud was committed at the expense of farmers in Kamouraska County last fall by a well dressed sharper, who, under the assumed profession of grain dealer, went from farm to farm to purchase oats at 50c. per bushel, to be delivered in January. Contracts were signed in duplicate, and it appears that the duplicates in the purchaser's hand were nothing else than promissory notes, which have been transferred to other parties in Montreal, who want immediate payment. It appears that over 80 car loads of oats were ready for shipment. The farmers of St. Anne. Riviere Quelle, St. Denis and Kamouraska have been the most imposed upon. Those having sold, for instance, 400 bushels of oats, have signed notes for
