What is the Use of it?

As announced in last week's Gozette, and again in this issue, there is to be a a meeting of the Patrons of Industry at Kinmount on Wednesday next, the 14th inst., and a monster gathering at Fenelon Falls on the 15th, when addresses will be delivered by J. O. Curry, vicepresident of the association, and George Wrigley, editor of the Farmers' Sun, the Patrons' official organ. What good it will all do, beyond amusing the farmers without hurting anybody else, is more than we can imagine, unless the Reform members of the organization can convert the Tories and persuade them to vote "agin the Government" at the next Dominion election. We used to think that the object of the Patrons, like that of the defunct Grangers, was to obtain at wholesale prices, everything they were compelled to buy, which they can no more do than they can fly to the moon; but at the meeting held here on the 28th ult., any desire to deprive retail dealers of fair profits was disavowed; their object being to "commence with the manufacturers where the huge combines exist." That the Patrons are on the right track is plain enough; but if any member of the association, officer or private, will kindly arise and inform us how the combines are to be suppressed without ousting the Government that fosters them in return for ante-election cash considerations, we shall feel much obliged for the information.

Mr. John Cruess of Mariposa, ex-M. P. P. for West Victoria, was at the Falls last Friday visiting relatives and spent a few mnutes in the Gazette office, and in the course of conversation said that he had always been a Conservative, but he thought the time had arrived for a general and material reduction in the tariff, and that if the pampered industries, that apparently have a longer infancy than human beings, cannot now. get along without pap, it is incumbent on them, in the interests of the general public, to curl up and die-or words to that effect: We preached to him; the same doctrine that we preach to everybody who cares to listen to us, viz That as a man cannot be saved from his sins without renouncing the devil and all his works, so the farmers cannot be relieved from the incubus that oppressesthem without renouncing the present Ottawa Government; with its ways that are dark and its tricks that (unfortunately) are anything but vain.
