Somerville Council Proceedings.

Burnt River, March 2nd, 1895.

Council met pursuant to adjournment. Members all present and the reeve in the chair. Minutes of last meeting read and confirmed.

Messrs. Morrison and Stewart reported re lot north half 17 and part of 18 in con. 3, that they had decided to wait until the snow was gone before making an examination.

Mr. D. McRea was heard, asking that the fee for billiard license be reduced, and it was

Moved by Mr. Stewart, seconded by Mr. Burtchall, That the fee for a license for a billiard table be reduced to \$12 a year.

Moved in amendment by Mr. Morrison, seconded by Mr. Griffin, That no reduction be made.

The original motion was carried and a by-law introduced and passed in the usual way to amend the by-law respecting billiard tables, in accordance with

the motion. Mr. W. Tipling addressed the council at some length respecting the snow blocking the road at or near his place, showing that, there being so few men in his division, most of the labor of clearing the road of snow devolved upon himself, and that in consequence all his statute labor for the year was used in shovelling snow, and some days besides; stating also that a wire fence along the road would cure the difficulty, and that he would put up a wire fence if the council would furnish half the wire, and would forego his claim for pay for time spent in clearing the roads of snow.

On motion of Mr. Griffin, seconded by Mr. Morrison, \$10 was granted towards purchasing wire for fence, Mr. Tipling to furnish a like amount and all other material and build the fence. Mr. Griffin to inspect the fence and see that it is substantially built.

A by law to appoint pathmasters and other officers; a by-law to appoint a medical health officer; and a by-law to remit dog-tax were read and passed.

The following accounts were ordered to be paid: J. Heard, road tools, \$7.50; John Suggett, deputy returning officer, \$3-returning ballot box, \$1; Henry Graham, deputy returning officer, \$3express on ballots box, 25c.; A. H. Carl, room for election, \$2; L. O. L. 1109, hall, \$2; L. O. L. 541, hall for election and nomination, \$3; J. Fell, attending meeting of board of health, \$1.25; Sam Suddaby, do., \$1.25; Jno. Howie and Henry Doughty, attending meeting and mileage, \$1.85 each; H. Grabam, do., \$2.25; C. D. Barr, registering plans and making researches, \$19.80; A. Atcheson, goods supplied F. Taggart, charity, \$4.20; J. Laplant, balance as messenger at R. Mansfield's, \$1; Clerk, postage, \$2-on acc't salary, \$25; Alex. Morrison, paid for search of titles at registry office, 50c.; Henry Graham, goods supplied to A. Mitchell while isolated on account of diphtheria, \$9.20; Charles Rawlinson, messenger at Mitchell's, \$9 50: J. W. Suddaby, auditor, \$8; J. Kingsboro, auditor, \$8; A petition of Wm. Fell and forty-two

others, praying that a bridge be built across Burnt River on the 7th con. line, was laid before the council. Moved by Mr. Morrison, seconded by Mr. Griffin, That the reeve and clerk

prepare plans and specifications of a bridge to be built across Burnt River on the line between cons. 6 and 7, and the reeve and Mr. Stewart be commissioners to let a contract of building said bridge.-Carried.

Moved by Mr. Morrison, seconded by Mr. Burtchall, That the parties whose buildings were burned in Kinmount. about the 1st of September last be allowed 25 per cent. off their taxes, and that the collector be instructed accordingly .- Carried.

Moved by Mr. Stewart, seconded by Mr. Griffin, That the collector be allowed an abatement of \$9.86 charged against north half lot 8 con. 5, south half lot 9 con. 5, and north half lot 9 con. 4, and that said taxes be returned to the county treasurer for collection .-Carried.

Moved by Mr. Stewart, seconded by Mr. Morrison, That Thos. Byrnes be allowed \$3 for timber for three culverts and one day's work on the road .- C'd.

Moved by Mr. Burtchall, seconded by Mr. Stewart, That the auditors' report be accepted and the clerk get 250 copies printed for distribution .- Car'd.

A communication from the Single Tax Association was laid over for one year for consideration, and the counciladjourned, to meet on April 13th at the same place.
