"Go to now ye rich men, weep and howl, for your miseries that shall come upon you. Your riches are corrupted, and your garments are moth-eaten. Your gold and silver is cankered and the rust of them shall be a witness against you, and shall eat into your flesh as it were fire. Ye have heaped together treasures for the last days Behold the hire of laborers, who have reaped down your fields, which is of you kept back by fraud crieth : and the cries of them which have reaped, have entered into the ears of the Lord of Sabaoth. Ye have lived in pleasure and have been wanton. Ye have nourished your hearts as in a day of slaugh-

The above scripture needs no explanation. What a terrible picture, but not overdrawn. Everyone knows that it is true. True for our time as for no other. Gold and silver is "corrupted" because obtained by "fraud." "Cankered" because it will be a source of "misery" and trouble to the owners. Treasures "heaped" up. A word used nowhere else in the bible in connection with riches. Certain it is that the inspired penman used the proper word, "heaped," when applied to our day.

Who has done this heaping? The Trust owners. And the cry of labor has gone up because a just recompense has not been made for the service rendered. Let no one think that capital will tamely submit. The contest will be bitter, but the dullest intellect can see from the above scripture who will drink the bitter dregs. It is elsewhere said of these days that " The great man asketh and the judge taketh a bribe." If this will not apply to the legislature and the supreme court of our neighbor state, it is at least open to that objection. I am not an anarchist or an alarmist, but a nondescript in politics. I believe we are sitting on a volcano, sur-charged with wrong, oppression, lust of wealth and power, and the longer the explosion is delayed, the more disastrous will be the results.

The Dangerous Element.

No one man ever bribed a court, a jury or a legislature as a citizen-it was always done to get an advantage as a property owner-to get wealth to hold individually. Therefore must public wealth take the place of private wealth. If the Watchman refuses to open its eyes to this truth, then it is the blind leader of the blind .- Appeal to Reason.

Revolution in Russia.

Recent cables from Russia say that the peasants, driven to desperation by the extortions and oppressions of their masters, have begun to use the torch, as the only weapon available, to destroy the property of the great lords of the lands. Another revolution, more fearful-than the French, is slated for Russia. The working class in Russia, long oppressed, have learned that it is, the possession of the wealth they have created that enables the tyrants to hire mercenaries to keep them in power, and that, if the cities and towns were destroyed, the rulers would have no means of either hiring or feeding the soldiers who do the murdering of the working people for the czar.
