





KUROPATKIN RETREATS

Russian General Begins the Running to the North.

Russians Beaten in a Hot Six Hours' Fight and the Japanese Thereby Occupy Fenshulling, Twenty Miles Northwest of Siuyen-Jap Major Oba Was Killed in the Battle-Port Arthur Squadron May Have Gone to Vladivostock.

Tokio, June 29.—After a hot fight, which lasted for six hours Monday morning, June 27, the Takushan division of the Japanese army completely defeated five battalions of Russian infantry, which was supported by two regiments of cavalry and sixteen guns, and occupied Fenshuiling, twenty miles northwest of Siuyen. The Russians finally fell back in the direction of Shimucheng. The Japanese casualties aggregated about 100 killed and wounded. Major Oba was killed during the battle. The Russians fled in disorder. Kuropatkin Retreats.

St. Petersburg, June 29.-The Associated Press is informed on good authority that General Kuropatkin has decided to withdraw northward. This move gives the Russians the advantage of being nearer their base of supplies and placing the Japanese at the disadvantage of having longer lines of communication.

It is pointed out that Kuropathin no longer prevents a junction of the enemy's forces by remaining at Tatchekiao as he might thereby imperil the safety of his own troops, as the desperate character of the fighting at Ta Pass and Fenshui Pass, June 27, shows the Japanese are in strong force uncomfortably near the Russian flank.

A report that Rear-Admiral Withoft (in command of naval forces at Port Arthur) sailed off after giving battle to the Japanese, receives credence. Withoft is known to have full authority to leave Port Arthur if he deems it advisable, and he possibly preferred not to risk a return to the harbor which again might be blocked, preventing his egress at a critical moment. Consequently Withoft may now be steaming to join the

Vladivostock cruisers. Russ Battleship Stranded.

London, June 29.-A despatch to the Central News from Tokio says it is reported that another Russian battleship has been discovered stranded off Tiger Rock. It is presumed she was wrecked while returning to Port Arthur after the recent naval engagements.

Fight Expected To-Morrow.

Haicheng, June 29 .- A heavy engagement is expected to-morrow near village of Shimucheng, fifteen miles south-southwest of Haicheng, and an equal distance due east of the railway. The Japanese have now passed Dalin Hill and are twenty miles south of the Russian position. The total losses in the Dalin Hill fight are not yet known. Eighty wounded have arrived here and on Sunday last a hospital train with 200 passed, going to Liaoyang. The fighting lasted the whole of June 26 and 27.

One Shot, One Dies of Fever.

Newchwang, June 29 .- H. J. Middleton, Associated Press correspondent with the Russian headquarters near Liaoyang in Manchuria, died Sunday from enteric dysentery.

Tien-Tsin, June 29.—It is reported that Edward F. Knight, the correspondent of the London Morning Post with the Japanese army, was killed at Wafang-Tien.

Said He Was Offered Money.

Hamilton, June 29 .- At a special meeting of the Board of Works last evening ex-Ald. James Miller made a sensational charge against Justice Teetzel. He declared that before His Honor was elected to the bench and while acting for the G.T.R. he offered him \$300 not to oppose the closing of Robert street. Mr. Miller, who owns property at the corner of Robert and Elgin streets, said he refused because he would not injure his neighbors.

Counterfeiters Remanded.

Toronto, June 29 .- There were no new developments in the counterfeiting case. Both men were arraigned in the police court yesterday morning. Decker, who claimed to be an American citizen, was remanded until this morning, to give him an opportunity to consult with the American Consul. Higgins was given a week in which to consult his friends.

Kingston to Get Its Own,

Kingston, June 29 .- By an agreement concluded last night, the city of Kingston will, on the 1st August, take over the plant of the Kingston Light, Heat and Power Company. The total cost, including interest, is \$211,857.

ENTRY WAS QUIET.

Lord Dundonald Himself Dispenses With Guard of Honor.

London, June 15 .- Lord Dundonald, accompanied by his aide-decamp, Capt. Newton, arrived in this city at noon yesterday. Lord Dundonald's entering into London was very quiet, and that he felt the then uncertainty of his position was evidenced by the fact that he wired ahead to this city to make no display of any kind and to not provide the usual guard of honor.

The G. O. C. visited Carling's Heights during the afternoon and inspected the second brigade, which was put through the Dundonald drill, and he appeared to be satisfied with the officers and men. He did not, however, hold a general review.

The Niagara Militia Camp.

Niagara-on-the-Lake, June 15 .- In almost perfect weather the Niegara camp was opened yesterday. By nightfall from 400 to 500 tents dotted the plain, and everything is now in readiness for the opening of routine to-day. The camp consists of the 3rd, 4th and 5th Brigades of Infantry, the Cavalry Brigade, the 4th, 7th and 9th Field Batteries, Army Service Corps, 4th and 7th Field Hospital Corps and a squad of Royal Engineers. The 3rd Brigade, commanded by Lieut.-Col. Delamere, is made up of the 37th, 39th, 44th and 77th Regiments; the 4th Brigade, by Lieut.-Col. Mason, is made up of the 12th, 31st, 34th and 86th; the 5th Brigade, by Licut .-Col. Cruikshank, is made up of the 23rd, 20th and 85th. In the Cavalry Brigade are the 1st Hussars, G.G.B. G., 2nd Dragoons, Toronto Light Horse. The only new regiment this year at camp is the 23rd of Parry Sound. The 97th, of last year, is at the Ottawa camp.

THE DOMINION HOUSE.

Ottawa, June 15 .- In reply to Mr. Borden, who asked when the orders of the day were called if there was any Government legislation that had not been placed before the House, Sir Willrid Laurier replied that there would be some minor measures and an amendment to the election law. He promised to explain the nature of the amendment later on.

Mr. Borden resumed the debate on the budget, and he was followed by Sir Wilfrid Laurier. Both leaders discussed the tariff question very fully. from their respective view-points.

The debate was continued by Messrs. Holmes of West Huron, Broder of Dundas, Hughes of Kings, P. E.I., and Uriah Wilson.

Mr. W. F. Maclean intimated that the arrangement made by the Railway Committee to consider his bill establishing a two-cent passenger rate on the 28th inst. would not prevent him moving the same in the House in amendment to Mr. Fitzpatrick's bill.

Doctors Were Up Early.

Toronto, June 15 .- One hundred doctors assembled and began work at 6.30 yesterday morning in the University Medical Building. Technical papers were read and nominations for office made. The annual dinner will take place at 1.30 this afternoon.

To Raise the Canada.

Montreal, June 15 .- A meeting of the directors of the Richelieu & Ontario Navigation Company has decided to call for tenders for the raising of the steamer Canada.

Mining Co. Restrained.

London, June 29.-(C. A. P.)-Justice Farewell yesterday granted an injunction restraining the directors of the Gold Run Klondike Co. from paying dividends until the lapse of 14 days after the general meeting and also ordering repayment to the company of £25,000 paid to the credit of the Canadienne Co. out of the Klondike assets. The defendants to pay the costs of the action.

Barchard's Factory Burned.

Toronto, June 29 .- The Barchard planing mill and box factory on Duke street, near Berkeley, was burned \$2,000 worth yesterday before the flames were extinguished.

Will Give \$2,000,000.

Paris, June 29 .- Baron Rothschild will give \$2,000,000 to provide cheap and healthy dwellings for the Parisian working classes.
