

At the conclusion of the hour during which nominations could be madethat is to say, at 1 o'clock-Mr. Junkin was asked, and consented, to occupy the chair, and the speaking commenced It was very brief, and the chief interes seemed to centre in the doings of the Board of Water, Light and Power Commissioners. Mr. Edward Fitz gerald complained because the auditors' report had not been published by them. The reeve and solicitor held that the Board had complied with the law in the matter. Commissioner Martin reported as to the financial transactions of the Board as far as possible at the present stage of the development work. The Chairman of the Commissioners reported that in his opinion electrical energy could be furnished the citizens of Fenelon Falls at \$8 per h. p. without loss, and that contracts for supplying 155 h. p. had been made with the Sandford Furniture Co. and the Fenelon Falls Milling Co. Mr. McArthur thought the power could not be sold for less than \$10 per h. p., as in his opinion it could not be developed and distributed for Some further discussion took place as to the action of the commissioners in purchasing the 100 h. p

water from the Sandford Co. A change in the municipal election law makes it incumbent upon a person who is nominated and who intends to run to file an affidavit of qualification with the returning officer before 9 p. m. of the day succeeding the nomination. The new requirement was read in a distinct voice at the nominations by Mr. Junkin, yet it was forgotten or disregarded by all except one of the nominees for the reeveship and four for the council, and they were declared elected

as follows : Reeve - Joseph McFarland. Councillors-Lewis Deyman, Geo. H. Littleton, Geo. H. McGee and Dr. Sims.

Some other papers were given by proxy to the returning officer; but as they were neither sworn to nor signed by the candidates, they were of course disregarded. The school board will be the same as before, as the three retiring trustees were all nominated and reelected without opposition. It is yet undecided whether there will be an election for the board of W., L. and P. Commissioneas.

The statutory meeting of council was held on the 15th inst. at the town hall, Bobcaygeon, the reeve, J. D. Hunter, Esq., in the chair, and councillors Geo. Brooks, J. J. Devitt, E. Tiers, D. Mc-Farland present.

The reeve reported on the Middleton swamp road as follows: He had let 108 rods to W. J. Killaby and Archie Campbell to grade and ditch for \$160, and two culverts for \$15, and T. Germyn to clay, stone and build one culvert for \$40, and also let to Wm. Logan by auction the repairing of quarter line 144 rods at \$1.50, 50 rods north from where T. Germyn left off at \$1.75, and the balance at \$2.

On motion of Messrs. Devitt and Mc-Farland a by-law was passed establishing a 50 foot road from 2nd and 3rd con. line to Dansford station.

Communication was received from the solicitor relating to the \$1730 railway debenture refund of interest for '01, '02 and '03, stating that, as the money had been raised for a definite purpose, it would be safer to put the money to a special account to pay debentures of '05 and '06 and balance on '07, and enclosed a by-law covering thesame, which was accordingly passed on motion of Messrs. Devitt and Brooks.

A petition signed by Alex. Robertson and 46 others asked that a road be opened from the Bobcaygeon road to the Dunsford station, which would require about 12 acres from Silas Thurston.

Brooks-McFarland-That the petition be laid over till next sitting, in the meantime the reeve to ascertain the price of the required land, and obtain the approval of the railway Co.-C'd.

The reeve, reporting on the Thos. Salter case, reported that he had arranged with Wm. English to take him at \$40 a year, not to include medical attendance, which was approved on motion of Messrs. Devitt and Tiers.

On motion of Messrs. Devitt and Mc-Farland; an order of \$15, passed Oct. 20th, in favor of John Fell, was resoinds ed, as the work had not been performed.
