Fenelon Council.

Fenelon adjourned Court of Revision and council met at Cameron on June 6th. In the absence of the Reeve, Mr. Cragg took the chair. The minutes of the court held at Cambray on May 25th were read and adopted, on motion of Messrs. Moynes and Tolmie. After some other business had been transacted, the Reeve entered and took his seat.

Cragg—Tolmie.—That the following changes be made to the roll: G. E. Endicott be reduced from \$2,100 to \$1,950; J. McCormick be assessed as owner of east half of lot 21, con. 7, lately owned by Miss E. Brown, and that R. Byrnell be assessed as tenant of the same; R. Cochrane be assessed as tenant of house on east half of lot 17, con. 8, at \$100; Lawrence McGee and Donald Tolmie be added to the roll as farmers' sons; Arthur Landell, Robert Landell and Joseph Perrin be added to the roll as M. F.—Carried.

Tolmie—Palmer.—That the business tax of threshers be struck off the roll, as we believe they should be assessed on income, and that this court has no power to make the change.

Council then took up general business. The minutes of last meeting were read and approved, after dropping the motion made by Messrs. Tolmie and Palmer asking C. Everson to remove his fence off con. 5, it being found that Mr. Everson had no fence on the road. The following motions were passed by council:

Palmer—Moynes.—That a by-law be now introduced authorizing council to expend money on the roads, and appoint commissioners for same.

The by-law was introduced and passed in the usual manner, Mr. Tolmie in the chair.

Tolmie—Moynes.—That the Reeve and Treasurer be authorized to borrow the sum of \$600.

Cragg—Tolmie.—That the Reeve be appointed to see H. Evers re widening road at his lot east of Cameron.

Moynes—Palmer.—That Geo. Switzer be granted \$10.00 compensation in full for piece of ground described in by-law No. 555, he to sign a conveyance to township for same.

Palmer—Moynes.—That E. Mark be granted the money paid in roadwork to build cement tank at the spring on said beat.

Moynes—Tolmie.—That the township printing be given to R. J. Moore on same terms as last year. Amendment by Palmer and Cragg, that the Fenelon Falls Gazette be given the printing on said terms. The Reeve declared the original motion carried.

Palmer—Cragg.—That the following bills be paid:

Each councillor and Reeve for inspecting road at Rosedale, \$1.50; A. Sackett, for finding stake, 50c.; D. Tolmie, inspecting Victoria road re Graham's culvert, and reporting no need of said culvert, \$1.50; M. Maybee for two meetings in Orange Hall, \$4.00.

Council then adjourned to meet at the call of Reeve.

Somerville Council.

Burnt River, June 15th, 1908. Court of Revision resumed. Present, Messrs. Callan, Carew, Hoskins, Pell and Davis. Minutes of last meeting read and confirmed.

Carew—Fell.—That the roll as revised be the assessment roll of 1908.—Carried.

Court of Revision being concluded, the minutes of council were read and confirmed.

Mr. T. Hunter addressed the council re culvert.

Hoskins—Davis.—That Mr. Hunter be a commissioner to put in culvert and put in bill.—Carried.

Carew—Fell.—That the clerk notify A. Fell, path-master, to have Mrs. Jones' fence removed off road allowance.—C'd.

Davis—Hoskins.—That Thos. Byrnes be paid a bonus of 20 cents a rod for 62 rods of wire fence on 9th line, opposite lot 3.—Carried.

Carew—Davis.—That ten dollars be granted to be expended on crossway on 9th line; Thos. Byrnes to be commissioner to expend the same.—Carried.

Mr. Jas. Newman addressed the council re a gully on side-line lots 3 and 4, con. 11.

Hoskins—Fell.—That Mr. Davis inspect the place, and report at the next meeting of council.—Carried.

Mr. Joel Henderson addressed council re money on his beat. Mr. Davis to examine and report; also McNamare's road.

Carew—Davis.—That twenty-five dollars be granted to be expended on side-line between lots 12 and 13, con. 7; and that E. R. Hopkins be commissioner to expend the same.—Carried.

Carew—Fell.—That ten dollars be granted to be spent on the 3rd line; Edmund Watson to be commissioner.—C'd.

Mr. John Wilson addressed the council re road.

Hoskins—Fell.—That twenty-five dollars be granted to be expended on hill on side-line lots 21 and 22, cons. 1 and 2.—Carried.

Hoskins—Davis.—That forty dollars be granted to be expended on Carew's division; S. R. Carew, commissioner.

Fell—Carew.—That thirty dollars be granted to be expended on side-line lots 21 and 25 in 4th con. 1, J. T. Graham to be commissioner.—Carried.

Hoskins—Carew.—That Mr. Fell be instructed to have necessary work done on Cameron road at lot 5 F. R.—Carried.

Hoskins—Davis.—That thirty dollars be granted to be spent on side-line lots 3 and 4, cons. 1 and 2; John Schell to be commissioner.—Carried.

Carew—Fell.—That thirty dollars be granted on third line from lot 12 to lot 16; Thos. Bulmer to be commissioner.—Carried.

Carew—Hoskin.—That John Schell be given a contract of clearing the road allowance on third line from lot 4 to lot 7,

four rods wide, for fifty dollars.—Carried.

Carew—Fell.—That twenty-five dollars be expended on the blind line between 1st and 2nd cons., from lot 21 to lot 25; John Suggest to be commissioner.—Carried.

Davis—Carew.—That ten dollars be expended on the north boundary; James McKay, pathmaster.—Carried.

Carew—Hoskins.—That twenty dollars be spent on side-line between lots 9 and 10 in con. 2, John Golden commissioner; and twenty dollars on side-line between lots 12 and 13, from boundary to con. 4, Jas. Armstrong commissioner; and ten dollars on Monck road, J. L. Davis commissioner.—Carried.

Carew—Davis.—That By-Law No. —, a by-law to authorize the building of bridges, be now read and passed.—Carried.

Hoskins—Carew.—That the following accounts be paid: A. B. Townsend, assessor's salary, \$75, and for checking roll, \$2.50; total, \$77.50; Sam Suddaby, checking roll, \$2.50; E. R. Hopkins, work at bridge, \$2.50; R. Reeds, work on road, \$1.50.—Carried.

Mr. J. H. Hampson, of the Sawyer-Massey Co., interviewed the council.

Carew—Fell.—That cedar at Mitchell's bridge belonging to Mr. Brisbin be purchased at five cents per lineal foot, to be used in culvert by John Wilson.—Carried.

Carew—Fell.—That council adjourn, to meet on Saturday, Aug. 8th, at Burnt River.—Carried.

The Government tug Bob Hall happened along shortly afterwards and towed the disabled craft to Lindsay, where repairs were made.

ANNIVERSARY AT ZION.—The congregation of Zion Church, Fenelon, will hold anniversary services at Zion, on Sunday, June 21. Service at 2.30 p. m. by Rev. J. A. Ferguson, of Glenora. Service at 7.30 o'clock by Rev. C. S. Lord, of Fenelon Falls. On Monday, June 22, three neighboring ball teams, with the home team, will play in the afternoon, instead of the afternoon programme by the children. Tea will be served from 5 to 8 p. m. Platform service in the evening, recitations and singing by the children and choir. Addresses by Revs. Lord and Cragg, of Fenelon Falls, and the pastor. A BAD SPRAIN.—On Saturday morning last, while Mrs. James Byrnell, of Fenelon, was milking one of a number of cows, the animals were suddenly alarmed by a horse and colt in the same field, and commenced running. Mrs. Byrnell was knocked down and run over by a couple of the cows, receiving such a severe twist and sprain in one of her legs that she is still confined to her bed and unable to use the limb. It was at first thought a bone was broken, but such was not the case. Dr. Gould is in attendance.

FISHING.—Tuesday was the opening day of the fishing season, and many residents of the village were out on the lakes bright and early. The fish were biting well, and very few fishermen returned empty handed, though no very large fish were brought home. The Rev. C. S. Lord, who became a resident of the Falls only late last season, made his debut as a fisherman on the morning in question, and landed perhaps the first "lunge" of the season, an eight pounder, which he caught at half past four o'clock. That's not bad for a beginner.

SERIOUS ACCIDENT.—Victor Chambers, second and youngest son of Mr. Edward Chambers, Jr., of the Falls, met with a painful and very serious accident in Mr. Teirs's planing mill on Wednesday morning. He is employed in the railway office, but had gone to the mill, which is only a few rods from the station, to get some strips of wood cut by one of the band-saws in the mill. As all the employees were as busy as they could be, "Vic" undertook to cut the strips himself; and, while so doing, his left hand by some means came into contact with the saw. The thumb escaped injury and the little finger was only slightly torn; but the first and third fingers were cut off between the first and second joints, and the second finger was cut off between the knuckle and the joint below it. The ragged ends of all three fingers had to be amputated, and the operation was performed by Drs. Wilson and Gould.
