Burnt River Telephone Co. Meets.

The Burnt River Telephone Company, Limited, held their annual meeting at Burnt River last week. The auditors' report was submitted, showing receipts, capital, \$520, disbursements, capital, \$522.18, leaving a balance due the secretary of \$2.18 gross. Receipts, revenue account, were \$332.68, disbursements \$330.45, leaving a balance on hand of \$2.23. Of this, \$87.31 was paid the Bell Telephone Company, \$155 was passed to capital to pay off indebtedness, cost of putting up the line. In order to pay all outstanding accounts the directors borrowed \$200, which does not show in above accounts. The secretary was of the opinion that another year's operations would pay that, and after that there is no reason why the company should not pay a dividend on the stock.

The secretary said he had difficulty in convincing some of the municipalities that the company, operating as it does a party line telephone, is exempt from taxation under subsection 2 of section 14 of the assessment act; and that he short speeches were given by the offhad introduced the subject of taxation of rural telephone lines at the meeting of the Independent Telephones Association, where perhaps one hundred rural companies were represented, and he found there that the township of Verulam, and possibly Fenelon, occupied the proud positions of being the only townships that try to tax rural telephones. He said that there is no tax on money invested in mortgages or otherwise drawing interest until the income therefrom amounts to five hundred dollars or more, and then only on the income or product of the money. The more progressive neighbor, who puts a little money into a rural telephone, which is a benefit to all, is taxed. He would find no fault if the tax were based on the | Sir,income, but as the law is now interpreted by greedy municipalities it is grossly unjust.

It was moved by J. R. Mark and seconded by J. Flett, and resolved, That a memorial be sent the Legislature through our representative, Dr. R. M. Mason, asking that the law be amended so as to relieve rural telephones of tax-

Would you permit me to make a suggestion-one which I have been waiting for years (!) to be made by some one else--with reference to the election of school trustees in this village? I believe it would be an exceedingly wise move to appoint one of the clergymen who occupy our pulpits on Sunday to this position. It is not for me to suggest any one in particular, but surely we have in the four Protestant clergy some one who has distinguished himself in academic life, and who is in a position thereby to render valuable aid in many matters which come up from time to time in a school board.

If possible, a school board ought to be distinguished by two leading characteristics - business ability and culture; and, I believe, if the above suggestion is accepted and acted upon, you would, at least, have realized the last essential quality; while in the other members of the board, who are generally men engaged in the active pursuits of commerce, you would have the practical aspect. I do not mean to suggest for a moment that the clergy lack executive ability, but generally they are to-day distinguished by higher educational advantages than the average layman.

Local Option and Taxes

The official statement of receipts for 1908 shows that the village treasurer received from license fund for the three hotels two hundred and fifty dollars as the village portion of the license fees. To make up this amount in taxes would cost the ratepayer five cents for each hundred dollars of assessment, or, in other words, where the taxes are less than nine dollars the increase would be less than twenty-five cents. We appeal to this class for their vote in favor of Local Option. To close the bar-rooms is surely worth more than this in the greater safety of the growing up boys and young men of our village.

Local Option and Business Interests

We may assume that the business men pay three-fifths of the taxes, or \$150 of the decreased revenue. Of the ten thousand dollars or more per annum usually spent over the bars by their customers, the business men will surely receive more than one thousand dollars of the savings, and the profit from this will make up the loss in taxes. The experience of business men in towns where local option is in force is far better than this. Business men can not afford to lose this opportunity. We appeal to them for their support at the polls.

Bar-rooms and Morality

We need not tell you that the moral standard of the bar-room is away down below zero. We need not tell you that the regular customers of the bar-room are not receiving benefits which will help them in the serious responsibility of training their children for good citizenship. We need not tell you that the influence of the bar-room does not help to make men kind husbands or considerate providers for the needs of their families. We appeal to the men who patronize the bar-rooms to think seriously over these problems, and we believe if they allow their better judgment to prevail many of them will be ready to help us to carry the Local Option bylaw at the polls on January 3rd.

Bar-rooms vs. Churches

We need not tell you that the barroom is not the friend of the Church. It cannot fail to please. Robson's Drug is said the bar-room would destroy the Church if it could, and the Church could destroy the bar-room if it would. No doubt the latter statement is true.
