#### Charged With Fraud.

The following appeared among the news despatches in Monday's Globe, and will be of interest to Gazette readers, as Mrs. Rice addressed a meeting in Fenelon Falls on November 1st:

Welland, Dec. 22. - Considerable excitement has been caused by the arrest here of Chester Rice, charged with fraud. He was representing him. self as the agent of the Brunswick-Balke Collender Company, manufactu rers of pool tables, and trying to sell the exclusive right to games called billiard pinole, asking part payment in advance. Rice claimed to be trying to raise money to pay his mother's hotel bill here, also enough money to reach Hamilton. Mrs. Rice. who with her son and manager, Horatio White, is staying at a local hotel, is styled the "girl preacher." She was here last summer speaking against local option. Rice claimed his mother was employed by the hotel-keepers of Ontario to preach against local option, that she had been engaged by the liquor dealers in the United States for the same work, but had not been paid as promised. The "girl preacher" has apparently had quite a career, both the Dominion Alliance, Toronto, and the Anti-Saloon League of America having a record of her services to the liquor traffic.

#### Ellis's Sentence Commuted.

The sentence of death passed on Hector Ellis, convicted of the murder of his brother-in-law, Lew Porter, near Minden, has been commuted to im prisonment for life. He was taken to Kingston Penitentiary this week.

### Not H. Brooks of Fenelon Falls.

The H. Brooks whose name appears in the return of convictions published in last week's Gazette in a case of breach of the liquor license act, is not Mr. H. Brooks of Fenelon Falls. The fact is mentioned in justice to Mr. Brooks, in order that no wrong impression may exist as to the orderly character of his hotel.

#### The Bobcaygeon Repeal Question.

Bobcaygeon, Dec. 12th, 1912 To the Editor of Fenelon Falls Gazette. Dear Sir:

In your issue of Nov. 29th you published an article from your Lindsay cor-respondent under the heading " Bobcaygeon Satisfied with Local Option." In justice to your paper's reputation for veracity, and in justice to those citizens of Bobeaygeon who look with distilyor upon Local Option, I ask you to be good enough to print this letter if by any chance you can find space for it.

As presented by your correspondent, you have given an entirely erroneous impression with regard to the feeling of the people of our village in regard to the by law.

the by law.

I have several objections to make to his articles, and, before presenting them to you I wish to state that I am in favor of any law which will tend to minimize the drinking of liquor, but that under the system in vogue in Bobcaygeon I find it exceedingly hard to keep from drink-

My first objection to his article is that he says 77 names were required in order to FORCE council to submit a by-law to the people to repeal the Act, and only

59 names were presented. I have gone over the voters' list my-elf, and have the word of our estremed Notary Public, Mr. G. W. Taylor, that to the best of his knowledge the number

required was 62, not 77. 2nd. The article says "THE NAMES ON THE PETITION SHOW THAT THEY HAD BEEN ALL OVER THE VILLAGE, BUT WITH ALL THEY LACKED 18 VOTES TO MAKE IT OF ANY USE." I admit that we cannot FORCE council to submit a by-law without haying 3 more names on the pctition, but I wish to point cut that the petition was virtually as much use as if signed by half the ratepayers, inasmuch as the law distinctly states that the council has the legal right to submit such a by-law without any petition whatever, and, besides, we were advised by at least one of the council that it was only necessary to show enough signers to justify council in putting the question to a vote of the people. Also, the petition was not "all over the village," as many citizens never heard of it who would gladly have signed it had they known of its existence. There was absolutely no organization, and everyone who signed it did so without the least amount of canvassing or

3rd. Your correspondent says: "Time COUNCIL RECEIVED THE PETITION AND PUT IT ON FILE, BUT TOOK NO ACTION IN THE MATTER." Why? I have canvassed every member of the council and the reeve, and, to a man, they wish to have Local Option repealed. They claim that their object in fling the petition was not to favor Local Option, but that, if laid over until another year, and if Fonelon Falls and Liudsay both decided against Local Option, we would be certain to get the by-law repealed here. I repeat, EVERY MAN ON THE COUNCIL AND THE REEVE IS AN OPPONENT OF LOCAL OPTION.

4th. Your correspondent says, "If Fenelon Falls and Lindsay carry Locat Option it will work still better." I admit that it would be impossible for it to work worse than it has, but I claim that such a statement is not a fact, cannot be proven true, and is nothing but the idlespeculation of a Local Option (not temperance) crank.

Why, we can get liquor from Toronto as quickly and more cheaply than we can

from either place.
