#### A Mistake about Canadian Feeling,

From the Western Home Monthly.

An amazing misconception of the mind of the Canadian people finds expression in the protest of the London Outlook against a proposal to place a bust of George Washington in Westminster Abbey. "It would be," says the London Weekly referred to, "the conversion of the Abbey into a scene of permanent wisible outrage upon all loyal iuhabitants of Canada." This may be taken two ways. It is possible to give the words the meaning that Canadians who would not consider it an outrage to have a bust of Washington placed in Westminster Abbey are not loyal. But surely this cannot have been intended. The intention must have been to declare that all Canadians would consider it an outrage. No doubt the Outlook says this in all sincerity. But could anything be farther fron the fact ? What Canadian cherishes, or has any reason to cherish, any feeling of outrage because a bust of George Washington is given a place in Westmintter Abbey? What harm did Washington ever do to Canada? Even if it were chargeable to him that he had in any way injured Canada, it is to the future we look, not to the past, and the future of human betterment is bound up with the friendliness of the two great English-speaking families. At the meeting in London at which the proposal was made that the placing of a bust of Washington in Westminster Abbey should be one of the ceremonies in celebration of the hundred years of peace between the British Empire and the United States, the Archbishop of Canterbury quoted from a poem written when the Prince of Wales, afterwards King Edward VII, visited the grave of Washington:

"Neither can one consent forever bind Parent and offspring, but they shall at length

A closer union in disunion find; In separation, strength."

The Archbishop of Canterbury, not the London Outlook, gave utterance to the sentiment which animates the Canadian people. It is difficult to understand what can have led the Outlook into such a curious miscon-

#### Verulam Council.

A meeting of the Verulam council was held at the Council chamber, Bobcaygeon, on Monday last. The Reeve, J. J. Devitt Esq. in the chair, and councillors Wm. Green, R. J. Mitchell, Chas. Logan

and D. McFarland.

The account of the Township Solicitor \$40 was passed and ordered paid Dr. H. O. Boyd, Medical Officer of Health, addressed councilirelative to his position. He had been health officer for 13 years, had given his time and advice free of charge for 12 years, with no expense for attendance on Board of Health meetings. By the new Health Act council were to pay a reasonable salary. His understanding was that the arrangement of the salary last year was good for all time. If council were not agreeable to this he was willing to send in his resignation any time.

Moved by Wm. Green, seconded by D. McFarland, that if Dr. Boyd is not willto serve the township ou the remunera-tion offered last January this council will accept his resignation as M. O. H .-

Carried.

Messrs J. B. Kennedy and J. W. Thurston addressed council respecting School Sec. 2 Dansford. They wished a By-law authorizing the issue of Debentures to the amount of \$6,000, and on motion of Messrs. Mitchell and Logan, the Clerk was instructed to have the necessary By-law prepared for next

A large depuation from Dunsford waited on council supporting a petition signed by W. Kennedy and 45 others moving that council pass a resolution and forward to Deputy of Public Works Ottawa that a wharf be built on Con. line Cons. 2 and 3 south of Sturgeon Lake. Mr. Ed. Thurston addressed council in favor of the petition. Mr. W. B. Kennedy had a mile of a lake shore east of the line which would be laid out into building lots. Mr. T. W. Thurston had lots laid out, Greenhurst park, and Mr. Henry Thurston that of Thurstonia. He claimed that the wharf at the Con. line would serve the best interests of all concerned better than one at the end of Thurston Avenue between Greenhurst and Thurstonia. Mr. T. W. Thurston said in opposing the request of petition that parties that he had sold lots to had no road to proposed wharf on Con. line. Mr. I. E. Weldon, barrister of Lindsay, appeared for property owners of Green-hurst. He pointed out that in the plan of Thurstonia Mr. Henry Thurston had a reservation of 33 ft. on the plan which barred his clients from access to the wharf except by travelling Thurston Ave. not yet open to 2 and 3 Con. line and on that line to lake.

Mr. Robt. Thurston supporting the petition said they asked it as their right. The wharf would be central for all. People would have to travel over no private property. He thought the interests of residents should be considered first over those of non-residents. Mr. John D. Hunter and Mr. Henry Thurs. ton, owner of Thurstonia Park, also made short addresses in support of the petition.

Mr. Weldon addressing council said he represented 23 property owners of Greenhurst who would be building cottages during the summer and would be quite an asset to the township in additional taxes. He asked council to use their best influence towards opening up Thurston avenue, which would be to the best interests of the township and his growth. clients.

Moved by Mitchell and McFarland, That in the opinion of this council a wharf built on the 2nd and 3rd Con. line south of Sturgeon Lake would serve the best interests of the cummunity, and that the Department of Public Works be memorialized to that effect .-- Lost.

Moved by Logan and McFarland, That in the opinion of this council the wharf should be built on the con. line, but that before memorializing the Depart-ment of Public Works to that effect the council in a body inspect the locality and that Mr. Thurston owner of Thurstonia park be interviewed with respect to release his reservation of 33 ft. so as to make free right of way between the 2nd and 3rd concessioe line, Thurstonia and Greenhurst Parks.-Carried.
