THE GAME LAW.—We have been informed that many of the people of this locality have been misled in believing that persons in the locality where deer exist have a right to hunt and kill them without license. This matter having been brought to the notice of Judge Dean by the county clerk his honor explained to the large number of people present in the division court, that no one can under the new game act attempt to hunt or kill deer without a license and explaining that the penalty for the slightest breach of the act is a fine of not less than \$20 or more than \$50 for each and every illegal act. We hope no one will be foolish enough to fall into the trap by these false rumors, as they are perfectly foundationless. No man can ever ride the law in this matter, or change it, except the legislature who passed the statute, and we hope none of the people in this locality will leave themselves open to the heavy penalty imposed by the new act for breach of its enactments.—Echo

MUSKOKA.

PARTRIDGE.—Partridge are becoming exceedingly bold, and to see one of the birds in town is not uncommon. Reeve King shot at and missed one which he observed on the roof of a house. Mr. Readshaw has seen several in his vacant lots, but being a man of peace refrained from shooting, perhaps because he hadn't a gun. Mr. Price, foreman of the G.T.R. mechanical department, on entering his office about ten days ago, found a live partridge on his desk, the bird having entered through the open door. Mr. Price captured his prize, tied its legs with string, and locked it up in the oil house. Going to the oil house later, with intention of taking it home and killing the captive, the partridge proved too quick for his captor, and flew through the door to freedom. This week Mr. Barnfield, Jr., while out for a hunt, found the same partridge much emaciated but still alive. His dog killed the poor bird, and Barnfield brought it in, who identified his workmanship in the string knotted about the partridge's leg.

A WORM FARM.—Joe Crawley is a Muskoka boy who has an angle-worm farm. He started it two years ago, and has made nearly \$100 by selling worms to city men who go fishing in the lakes and streams of the country in which Joe lives. The worm colony is kept in a large box, which covers the floor of an old shed. Joe filled the box with oil to within eighteen inches of the top. He and his brothers have been gathering the worms during the fall planting, and he thinks he put more than three barrels of fish bait in the angle-worm incubator. The worms thrived and increased in number even during the cold days of winter, when the thermometer drops twenty-five below zero. Fishermen leave orders for the worms with the postmaster or groceryman at Redwood near Joe's farm home, and the worms are delivered to the anglers. Joe sells his worms for \$1 a quart, and he guarantees his bait to be good big worms which will tempt the most cunning fish to take the hook.—Banner.

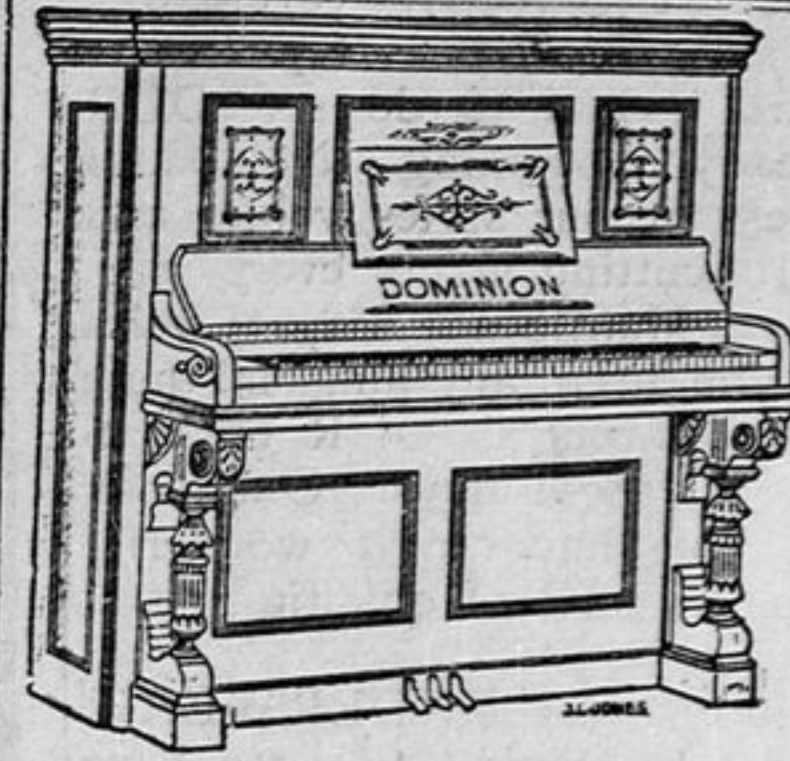
