CIVIL CASES.

SHEA: V. HAMILTON.—Interpleader issue to try the right to crops on west half of lot 16 in 9th con. and east half of 13 in 8th con. of Emily. The plaintiff claimed as lease of Jeremiah Shea his father, and the defendants as execution creditors of Jeremiah Shea. The jury failed to agree and were discharged.

Zatest News Items,

GREAT distress is reported among the German colonists along the Volga in Russia.

ILL-FEELING is reported between Uruguay and the Argentine Republic on account of the Argentines being impressed into the Uruguayan army.

THE late fight between the Russians and the Turcomans is reported to have been a severe one. It lasted four hours and the loss on both sides was very.

THE customs receipts at Winnipeg for the month of December were \$20,-607, more than double those of the corresponding month of last year, The value of goods imported from the eastern provinces of the Dominion for the month of December were \$272,852; an increase over the corresponding month of last year of \$194,746.

NEVER in the history of the United States has there been such difficulty experienced in shipping western products to the eastern markets and the seaboard The railroad companies are unable to handle one-fifth of the freight which is offered to them, and they have notified shippers that they will receive only perishable goods.

Four new French iron-clads are about to be put on the stocks. They will be 330 feet in length,65 in breadth and will have a displacement of 9.865 tons. Their engines will be of 6,000 horse power, and are expected to give a speed of 15 knots. The armour plating will be 18 inches thick, and the armament will consist of three 14 inch guns in turrets and 186 inch gans in battery.

London, Jan. 3 .-- A scheme to blow up the iron-clad, Lord Warden, guardship of the Firth of Forth, is supposed to have existed for the past week. A torpedo has been found beneath the

PREPARATIONS for the coming census of 1881 in London are being actively pushed. It is anticipated that the returns, will reveal a striking increase in the population of the metropolis, which cannot now be far short of 4,000,000. The census will be taken simultaneously in every district of the United Kingdom on the same day.
