

Mariposa Township Council.

Council met this 9th day of July 1883. Members present Messrs Adam, Broad, Lownsbrough and Bowes. Absent, Mr. Parkinson. Minutes of last meeting read and approved. Moved by Mr Broad seconded by Mr. Bowes that the Council grant the sum of \$10.00, to be expended on the Poundary line between Mariposa and Ops opposite the first Concession of Mariposa providing Ops expend the like sum. W. A. Casey Commissioner to act jointly with a Commissioner appointed by Ops Council-Carried. The Clerk read a petition from John Heatlie and 43 others for opening road between 12 and 13 Concession A. Also a petition from Thomas Smith and 76 others against opening said road. Moved by Mr, Lownsbrough, seconded by E. Bowes, that the petition of John Heatlie and 43 others praying that the road between Lots 12 & 13, Con. A, be received but this Council does not deem it expedient to grant the same. Carried.

Moved by Mr. Bowes, seconded by Mr. Lownsbrough, that the petition of Thomas Smith and 76 others praying this Council to sell the original road allowance running between Lots 12 & 13 Con. A, be received and that this Council rent the same to Thomas Smith Jr., at a rental of \$7.00 per annum instead of selling the same. And the said rent to be expended on the road beat in which said allowance for road is situate. Carried.

Moved by Mr. Lownsbrough, seconded by Mr. Broad, that the Reeve give his order on the Treasurer in favor of J. J. Cave for \$4.. 20 for advertising Court of Revision. Carried.

Moved by Mr. Broad, seconded by Mr. Lownsbrough, that the Clerk correspond with the Councils of the adjoining municipalities requesting them to agree with the equalization made in 1878 with the union school sections in this Township. Carried.

The Clerk read a copy of resolutions passed by Ops Council respecting a grant for the eastern boundary line.

Moved by Mr. Bowes, seconded by Mr. Broad, whereas the Clerk having read a copy of a resolution passed by the Council of Ops granting \$20.00 to improve the boundary line between Ops and Mariposa on condition that the Council of Mariposa grant the sum of \$40.00 Resolved that this Council grant the sum of \$20.00 for the improvement of said road providing the Council of Ops expend the like sum and that W. Lownsbrough be Commissioner to expend the same. Carried,

The Clerk read an application from the Trustees of Union School Section No. 4 Mariposa and Brock, for the issuing of Debentures.

Moved by Mr. Bowes, seconded by Mr. Broad, that the Clerk take legal advice and have a By-law drafted to give effect to the application made by the Trustees of Union School Section No. 4 Mariposa and Brock for a loan of one thousand seven hundred and fifty dollars for the erection of a new School House, to be submitted and passed at the next meeting of this Council

The Clerk read a petition from A. Cameron residing in the village of Oakwood.

Moved by Mr. Lownsbrongh, seconded by Mr. Broad, that the petition of A. Cameron and 17 others concerning the expending of money in making ditches in the village of Oakwood be received. Carried

Moved By Mr. Broad, seconded by Mr. Adam, that this Council assist the ratepayers of Oakwood to effect a drainage of said Village to the amount of \$50.00 W. Lownsbrough and John Cassiday, Commissioners..

Yeas. Lownsbrough, Broad and Adam, Nays. Bowes.

Carried. Moved by Mr. Broad, seconded by Mr.

Lewnsbrough, that the Clerk be instructed to have the necessary notices given in accordance with law to open parts of Flora and Edua streets in the village of Oakwood. Carried. Moved by Mr. Lownsbrough seconded by

Mr. Broad, that this Council instruct the Clerk to procure from Hart & Co. six copies of the consolidated Municipal Act. Carried.

Moved by Mr. Broad, seconded by Mr. Bowes, that this Council adjourn to meet again on the first Monday in August next. Carried.


District Jottings.

THE Midland Railway's appeal from the Court of Revision of the township of Thorah was heard in the Court House on Tuesday. before His Honor Judge Dartnell. The grounds of appeal were, over assessment on the station grounds and buildings at Beasverton, and upon the value of the roadwaythrough the itownship of Thorah. As to the first ground it appeared that the Assessment was no higher than it had been for several years. The Company objected that one building situated on their grounds did not belong to them, but to one Gordon, but as they had been assessed for years at the same rate, the Judge held that their remedy, if any, for this year must be against the owner, Gordon. As to the Roadway. it was found that the Company owned several acres more than they were assessed for, and the average value of the lands through which it passed was greater than their assessment.
