By-Law No. 9, of 1888.

A BY-LAW TO PROVIDE FOR THE ISSUE OF DEBENTURES TO THE AMOUNT OF \$2000 TO RAISE THE NECESSARY FUNDS FOR GRANTING AID BY WAY OF BONUS FOR RE-BUILDING AND RE-ESTABLISHING THE BEAVERTON FOUNDRY.

WHEREAS the re-building and re-establishing of the Beaverton Foundry lately destroyed by fire, would be of great advantage to the Municipality of Beaverton and greatly conduce to profit and prosperity of its inhabitants.

AND WHEREAS it is desirable that the said Municipality should grant aid in rebuilding and re-establishing the said Foundry to the amount of Two Thousand Dollars.

AND WHEREAS it is necessary to create a debt on the said Municipality to the amount of Two Thousand Dollars for the purpose aforesaid by the issue of debentures to that amount.

AND WHEREAS the existing debt of the said Municipality of Beaverton is Five Thousand Two Hundred and Seventyfive Dollars and the interest on the said debt at six per cent. per annum is Three Hundred and Sixteen Dollars and Fifty Cents and there is no amount due or in arrear either for principal or interest of the said debt.

AND WHEREAS the total amount required to be raised annually by special rate for paying the said debt of Two Thousand Dollars and the interest thereon as hereinafter provided is, for interest, One Hundred Dollars and for re-payment of principal Seventy Dollars.

AND WHEREAS the amount of the whole rateable property of the said Municipality of Beaverton according to the last revised Assessment Roll which is the Roll for the year One Thousand Eight Hundred and Eighty eight, is One Hundred and Forty-three Thousand, and Thirty-eight Dollars.

AND WHEREAS an annual special rate of one mill and two-tenths of one mill on the dollar upon the aforesaid rateable property of the said village of Beaverton will be necessary and requisite for paying the interest and forming an equal yearly sinking fund sufficient for paying off the principal of the said debt within the period of twenty years hereinafter limited in that behalf by Section 340, Sub-section 1 of the Revised Statutes of Ontario, of 1887, Chapter 184.

BE it therefore ordained and enacted by the Corporation of the said village of Beaverton and it is hereby ordained and enacted by the authority of the same.

I THAT this By-law shall take effect upon, from and after the first day of January in the year of our Lord, One Thousand Eight Hundred and Eighty-

II. THAT it shall be the duty of the Reeve of this Municipality and he is hereby authorized and required to issue debentures of the Municipality of Beaverton to an amount not exceeding Two Thousand Dollars, in sums of One Hundred Dollars each bearing interest at the rate of Five per cent. per annum and made payable on the first day of January, which will be in the year of our Lord, One Thousand Nine Hundred and

III. THAT the said debentures shall be each signed by the Reeve, countersigned by the Treasurer and sealed with the seal of the Corporation of Beaverton and shall bear date respectively on the day on which this By-law shall take effect and shall each be made payable to the bearer thereof.

IV. THAT there shall be attached to the said debentures. coupons for the payment of the said interest half yearly during the currency of the said debeutures, which coupons shall be payable at the office of the Standard Bank in the city of Toronto on the first days of July and January in each year.

V. THAT it shall be the duty of the Reeve of the said Municipality of Beaverton by the order and with the sanction of the Council thereof expressed by resolution to that effect, to sell, dispose of and transfer the said debentures to any person, persons or Corporation who may desire to purchase the same.

VI. THAT it shall be the duty of the Reeve of the said Municipality of Beaverton with the sanction of the Council expressed as aforesaid to apply the proceeds of the sale of the said debentures, less cost of issuing same, in aid of rebuilding and re-establishing the Beaverton Foundry and to take from the parties owning or re-building the said Foundry such agreements and securities as may be satisfactory to the Council of the Corporation of Beaverton for the due re-building and re-establishment of the said Foundry within the times and in the manner to be specified and set forth in the said agreement.

a sinking fund for the payment of the aforesaid debentures and for the payment of the interest to become due thereon at the rate of 5 per cent. per annum, a special rate of on mill and two-tenths of one mill in the dollar shall in addition to all other rates and assessments be raised, levied and collected in each year upon all the rateable property of the said Municipality of Beaverton, during the continuance or currency of

the said debentures or any of them.

VIII. THAT the sinking fund and special rates and proceeds thereof shall be applied solely to the payment of such debentures and the interest theron until such debentures and the interest thereon shall be fully paid and satisfied.

AND WHEREAS it is necessary that the foregoing By-law should receive the assent of the Electors of this Municipality duly qualified to vote thereon.

BE it further enacted that the said vote shall be taken at the Town Hall, in Beaverton, on the 10th day of September A. D., 1888, the said poll to be opened at 9 o'clock a. m. and be kept open until 5 o'clock p. m. and the village clerk be, and is hereby instructed to give such notices and take such order for a poll to last time this season. be held at that date as is prescribed by the R. S. O. 1887. Chapter 184, S. 203 to

AND IT is further enacted that the village clerk shall at the said Town Hall in Beaverton on the 11th day of September A.D., 1888, at the hour of noon or as soon after as may be make a statement of the number of votes given for and against this By-law and duly declare the results of the said poll.


