Proposed New Industry For Town of Lindsay

Knitting Factory to Employ Thirty or Forty Hands Likely to be Established

There are good prospects for the securing of another new industry for Lindsay. It is in the form of a factory for the manufacture of knitted goods, and would employ at least thirty hands at the beginning. It is now a going concern in Toronto, Mr. Hood being the proprietor, and to secure it for this town, all that is asked is the subscription of \$5,000 stock in the town. Towards this a good start has already been made. The matter was considered by the Council of the Board of Trade last Friday evening and a favorable conclusion arrived at, after hearing the report of Mr. Alex. Horn who went to Toronto to investigate.

A special meeting of the full Board was held in the Council Chamber on Monday night to consider the proposition. The attendance was small only some twenty five being present, partly no doubt owing to the unfavorable weather.

The President, Mr. John Carew, occupied the chair, and stated the object of the meeting. He regretted that there were not more present. Mr. Hood required some little assistance, the taking of \$5,000 stock. It was worthy of consideration at all events, and, if after discussion it was not considered worthy of assistance, let it drop. There was no doubt that if Lindsay became a manufacturing centre the citizens must bestir themselves and assist industries.

Mr. H. J. Lytle was called upon. He said that all knew his views on questions of this kind. One requisite in getting industries was that the man at the head of the concern should be a practical man. This was the case with the proposed industry. Mr. Hood was a practical man, but had not sufficient means to go on himself. He simply asked \$5,000 stock to be taken. He had machinery sufficient to employ 30 hands. About 75 per cent. of the labor would be women. He was satisfied that the articles turned out were first-class. The Penman factory started at Paris in a small way had recently been sold for \$4,000,000. The proposed industry might, if started, grow to large proportions. If fifty would take stock of \$100 each, it would make up the required aid. A number of small industries would be better than one large one.

Mr. Alex. Horn remarked that it had been said that everything went Peterborough's way. Lindsay was handicapped, by lack of power and by having few rich men. Peterborough had both. The knitting industry did not have the difficulties to contend against which the woolen industry had, as an old country yarn was used which came in almost free of duty. He had known Mr. Hood for a number of years, and knew that he turned out a good article. After turned out a good article. After having visited Toronto he was satisfied both with the men and the goods produced. He understood that Mr. Hood had an offer of a loan from another town, but preferred Lindsay. Mr. Hood was willing to have his salary fixed on a sliding scale according to profits. There was little or no doubt that good dividends would be paid.

Mr. Duncan Ray said that those who had examined into this question were satisfied that the man at the head was an absolutely honest, honorable man, and also that there would be a demand for these goods from the Atlantic to the Pacific. They would be an excellent advertisement for Lindsay.

Mr. W. Sparling thought that the men who recommended this project, Messrs. Lytle, Horn, Ray and others, gave a guarantee that it would be a good thing.

Mr. Montzambert would like to see the industry established. By each doing a little the proposed aid could be obtained.

Mr. R. Kylie favored the establishment of the industry, but he noticed that the men who were prepared to help it were the same who were helping all the industries. It might be a good thing to adjourn the meeting and formulate a plan for asking the Council to submit a by-law for a loan. There was a man in the town now than whom none, perhaps, had paid out more wages in the town, whose plant was idle, and if something could be done to keep the plant going it would be well.

WHAT SHALL BE DONE WITH THE MONEY

HOME FOR THE AGED HAS NEARLY \$2,500 IN HAND.

The annual meeting of the Home for the Aged Society was held in the Council Chamber on Tuesday evening, October 30, President Stewart in the chair.

The secretary reported that the work of caring for aged people in the Home ceased with the opening of the House of Refuge shortly after the last annual meeting, inmates with two exceptions being transferred to the House of Refuge. Upwards of ninety persons had been sheltered in the ten years the House was open. The furniture had been disposed of and the House sublet till the expiration of the lease, Nov. 15, 1906. The Board had continued the work of the ward dispensers.

The treasurer's report showed balance on hand October 1, 1905 of \$2,101.27; receipts, \$1,136.23; total \$3,237.50; expenditure, \$738.23; balance on hand September 30, \$2,499.27.

The ward dispensers had given \$76.45 to needy persons. The retiring officers were re-elected, namely, Thomas Stewart, President, Mr. McWatters, First Vice-President; Mr. Connolly, second Vice-President; Mrs. Sharpe, Secretary; Miss Twamley, Treasurer.
