



## KNOX AND DEWET STILL FIGHT

Their Desperate Battle Has Been Going on For Ten Days.

The Prolonged Effort to Capture the Shifty Leader of the Boer Guerrillas Has Not Been Ended Yet—Report That Boers Have Got Away Again, Leaving Only a Few Prisoners—Roberts Sails For Home—Canadians Sail To-day.

London, Dec. 12.—A despatch from Cape Town says Dewet was captured, with all but a few of his troops, who were captured by Knox. It is feared that he will join Botha, and that the two will succeed in invading Cape Colony.

This struggle between Dewet and Knox has been in a critical stage for ten days past. It has been waged under circumstances of extreme hardship for both combatants. The soldiers have had practically no sleep, and have marched and fought night and day, most of the time in heavy rains. Lord Kitchener's hand clearly appears in the manner of the pursuit. This pressing of the British troops with the same relentless rigor characterized the march from Kimberley to Paardeberg.

### The Battle Still Going On.

Later.—The Evening Standard says the battle between Gen. Knox and Gen. Dewet continues and that the forces change ground incessantly. Lack of definite information on the subject is said to be due to the absence of telegraphic communication with the scene of action.

While the War Office is most reticent on the subject, there are indications that the officials have received news suggesting considerable British success against Dewet.

### LORD ROBERTS SAILS.

The Field Marshal, With Lady Roberts and Their Daughters, Embarked For England.

Cape Town, Dec. 12.—Field Marshal Lord Roberts and his wife and daughters sailed for England yesterday on the Canada.

### The Reception to Roberts.

At the reception in honor of Lord Roberts yesterday, when the British commander rose to respond after the presentation to him of the sword and casket, all present rose to their feet, cheering and waving handkerchiefs. The demonstration continued for some minutes. At its conclusion, Lord Roberts made an eloquent address. After expressing deep thanks for the honors accorded him, he said the war in South Africa had a peculiar interest for him, inasmuch as it enabled him to bring to what he hoped was a successful conclusion of the work entrusted to him twenty years ago—that of dispelling, by force of arms, if necessary, the aspirations of the Boers to render themselves independent of British control.

### Sympathy For Boers Ridiculous.

Christiansburg, Dec. 12.—Henrik Ibsen, the dramatist, in The Orebabd, reiterates the statements he previously made against the Boers, claiming that they themselves formerly oppressed weaker peoples. He says he thinks the Boer sympathy manifested in so many countries is unwaranted, and rather ridiculous.

### Afrikaners Can Do But Little.

Durban, Natal, Dec. 12.—Replying to a resolution recently adopted by a mass meeting here, protesting against the attacks on Sir Alfred Milner, Governor of Cape Colony, by the speakers of the Afrikaner Congress, Sir Alfred has telegraphed that while he retains the confidence of the loyalists, he can afford to disregard such attacks. He added that there was no fear of the Afrikaners defeating the policy of annexation for the conquered territories.

### Ian Hamilton For the War Office.

London, Dec. 12.—It was said in the lobby of the House of Commons last evening that Gen. Ian Hamilton, who is returning with Lord Roberts, will receive a high appointment in the War Office.

### Joins Baden-Powell's Police.

Newmarket, Dec. 12.—Capt. James Wayling of Sharon, son of the late Col. Wayling, has volunteered for the South African police, and will leave to join that body as lieutenant at the beginning of January.

### Lieut. King on Duty Again.

London, Dec. 12.—The War Office reports that Lieut. W. B. King, formerly captain of the 7th Battery, C. A., now of C. Battery, Canadian Field Artillery, South Africa, has been discharged to duty.

### Meeting of Provisional Government.

Pekin, Dec. 10, via Taku.—At today's meeting of the Ministers, called to consider whether or not Li Hung Chang and Prince Ching had power from the court to conduct negotiations for a settlement on behalf of China, some of the Ministers stated that they were authorized to treat them as representatives of China, while others, including the German Minister, had not received instructions in the matter. All decided, however, that as soon as Sir Ernest Mason Satow, the British Minister, shall receive word to agree to the joint note, they will commence negotiations with Li Hung Chang and Prince Ching, unless otherwise instructed by their home Governments.
