THE TWINS' EXCUSE.

The Wobbling Brothers are having a hard time. In Mr. Hughes' labored attempt to justify straddling, he of course runs foul of old party friends. According to him, every man who voted for Mr. Laurier's amendment—the six months' hoist—was an ass, and every one who voted for the bill was an ass. This is pretty hard on Clarke Wallace, Cockburn, Bennett, Dr. Weldon and the host of others who voted with Mr. Laurier, and also hard on Mr. Fairbairn and others who voted for the bill. The silliest of all pretence, however, is that by voting against the six months' hoist he voted against the bill being introduced six months hence, and that by voting afterwards against the bill, he prevented it again being introduced. A child in parliamentary practice knows better than this. A bill that is rejected by a simple adverse vote can be introduced at any time again, even the same session, and this has been done this very session right under his nose. The Chignecto bill was defeated, but on Thursday last was reintroduced. Six months' hoist is the recognized parliamentary method of killing a bill. Mr. Clarke Wallace writes to his constituents on this point: "The six months' hoist is the only effective way known to parliament to defeat a bill." Poor Sam better settle it with Clarke Wallace. Verily, verily the way of the straddler is hard.

IN THE BLOOD.

It is evident that Mr. Hughes, M. P., realizes that he has made himself ridiculous by his facing both ways on the Remedial Bill. He struggles desperately in a long, tedious, weather-cock sort of explanation to humbug his supporters into at least believing him honest. There is a back-concession sort of ability about Mr. Hughes, coupled with braggadocio which draws attention to him as he passes, and, vain-glorious, he mistakes passing notice for admiration. He carries with him as he walks a "look-at-me" sort of air, and forsooth, not unjustly, because what he says is so. He is right and all the world is wrong. It is so, because he says so. He says: "Every man who supports Laurier's motion declares that, in his opinion, the bill should be read this day six months."

How worried old parliamentarians must be to find from Mr. Solomon Hughes, M.P. for North Victoria, that for centuries they have gone all wrong in their knowledge and learning of parliamentary practice. Poor Dr. Bourinot, the acknowledged authority, must write another book. In the old land Bourinot was held in high esteem, but the day after Mr. Hughes told all self-governing countries the real meaning of a "six months' hoist," the sales of Bourinot's books fell away, and to-day it is practically unobtainable. The publishers say a cyclone has struck them, and Dr. Bourinot has been living in a sort of nightmare ever since.

"How, then," says Mr. Hughes, "could a man justify himself by declaring now in favor of a second reading this day six months, and when that six months comes round, opposing his former vote." Well, that needn't trouble Wobbling Sam, because he won't be there six months hence to vote either way. But, if he were, the justifying business needn't trouble him, because in the length of time it took him to peruse the Hon. G. W. Ross' letter refusing his application for office, he flopped once before and he can flop once again.

"I heard his voice of the Major—I heard him exclaim: 'I have flopped once before and I'll flop once again.' It was possibly Mr. Hughes' well-known reputation as a flopper that scared his friends into offering him, as he tells us, 'personal preference' to vote straight—they appear to have supposed that was the only way to get him to vote straight. Well, they ought to be decent, and give him half what they offered him, for he went half-way with them. Perhaps the flopping feat was just then being mentally performed, and had the vote been less hurried his friends might have caught him on the back somewhat. True, he would have demanded his "pound of flesh." Now he can look half-virtuous, beat his breast like Sancho Panza, and trumpet to the world that he "promptly refused to listen to any such proposals."

WOBBLING SAM.

He admits attempts to bribe members. Dalton McCarthy's charges justified. In Friday's Warrier Mr. Hughes labors hard and long to excuse his "good-Lord-good-devil-vote" on the Remedial Bill, but his utter unconscionableness of the crime of attempted bribery is shown in his own words: "During the crisis, though very strong influences were brought to bear on Mr. Hughes to induce him to give up his principles on the school question for personal preference, he promptly refused to listen to any such proposals. This is just what Mr. McCarthy stated. The sorry spectacle is that Mr. Hughes is one whom his political friends sized up as being subject to a bribe of personal preference. When his own friends think he can be approached, he cannot blame his enemies for having such an opinion of him.

IGNORANCE OR DECEPTION—WHICH?

Mr. Hughes either does not know, or, if he does know, is silly enough to hope to deceive his supporters in North Victoria. Having made himself supremely ridiculous by his straddle-leg course on the remedial bill, he sets himself up as a teacher of parliamentary lore. Like the beggar who got on horseback, he becomes laughing stock even of his own friends, and he doesn't see it. We absolve him from an attempt to deceive, and prefer to believe he knows no better. He voted against the six months hoist, because the amendment meant, he asserts, that the bill should be read six months hence, and he wobbling John McGillivray, M.P., voted against the second reading of the bill because that meant, he asserts, the defeat of the bill. He has asked the Mail and other papers to publish a two column labored attempt along these lines to justify his course, seemingly conscious that he and his wobbling brother are on the asses' bridge.

Bourinot says: "It is customary for those who are struck out of a bill that the word 'now' be struck out, and the words 'this day six months' added at the end of the question." This was Mr. Laurier's motion. But "if the motion that the bill be now read a second time be simply negatived on a division the measure will disappear from the order book, and it may be revived at any subsequent time, as the house has only decided that it should not be read a second time, and the order previously made for the second reading remains good. When a bill disappears in this way from the order paper, it is competent for a member to move at any time that it be read a second time on—"

Thus the wobbler's excuse is true, but in a sense the very opposite to that he contends for. The six months' hoist means opposition to the bill, and Mr. Hughes, by voting against this, supported the bill. Then by voting against the second reading he left it open for any one, as Bourinot says, to bring it up again at any time. So much for Mr. Hughes' ignorance or attempt to deceive, which ever it be.

Mr. Hughes voted straddle-ways, and in his paper he claims the course he took was because he was an Orangeman. This is rough on the other orangemen in the house, including Mr. Clarke Wallace. The only Orangemen in the whole parliament do to the like were the wobbling twins, Hughes and McGillivray.

Mr. Hughes, the Mail states, requested publication of his excuses, another Mail did so, but noticing the damning admission against the government of its attempt to secure support by offers of preference, altered Mr. Hughes' guileless confession of guilt.

Mr. Dalton McCarthy's charges were true, and now that Mr. Hughes has confessed that he was approached with offers of personal preference to give up his views, the matter calls for general investigation by parliament.

EDITORIAL NOTES.

If the Manitoba school law was such an unspcakably bad one, why did not the Dominion government exercise its constitutional prerogative of disallowance? That is a question which has never been answered.

Late reports from the Transvaal are not reassuring. The volkraad has refused to allow President Kruger to visit London, and there are rumors of arming and fortifying. There are hints that Germany, France and Austria are behind the Boers, and the London Times says that whatever has to give way Britain will hold her own.

Making soldiers is, like every other business managed by the Dominion government, a very expensive business. On Wednesday Mr. Sandford Fleming presented to parliament his report as one of the official visitors to the Royal Military College, an institution run by Tupper's relative, which consumes a big slice of our "war expenditure." Mr. Fleming officially told parliament just what was common property before he reported. He says the concern is over-manned and expensive. There are in training 57 cadets, and to supervise them a staff of 37 officials is kept, exclusive of the catering department. He does not think the output of military graduates—14 each year in the last five years—is commensurate with the expense, and he points out that although each graduate has cost his suffering country \$4,000, besides \$1,450 paid by the cadet, these graduates have had scant treatment in the matter of appointments to the Dominion public service. According to the auditor-general's report, this concern last year cost \$37,018.12 for staff alone.

IT WAS A BIG FIZZLE

Tupper's Missionaries to the Manitoba Province

RETURN EMPTY-HANDED TO-DAY.

The Ottawa Government Would Not Withdraw the Remedial Bill, and as a Result No Compromise Could be Reached Between the Conference.

Winnipeg, March 31.—(Special)—There seems to be a general understanding that the school conference will terminate to-morrow and the Federal Commission will return to the Capital without having accomplished the object of their mission. Upon whom the greater amount of blame will rest for this result can only be determined when the official reports of the doings of the commissioners are made known. From what can be gleaned here it would seem that the hierarchy, by being too exacting, are liable to lose not only what they are striving for but the sympathy of the large body of tolerant Protestants. The first effort of the Federal Commissioners was to persuade the Manitoba Ministers to accept the Remedial Bill. This failing, the establishment of separate schools with thorough Government supervision was asked. In the event of a negative verdict of the people of this province at the polls, it was impossible for the Manitoba Ministers to go this length. In lieu thereof, the central committee understood that Messrs. Sifton and Cameron undertook to promise, on behalf of the Legislature, that every reasonable objection of the Roman Catholics to the present law would be removed and fairly offered for the segregation of the Catholics in the center of population, under the Public School Board. In other words, the administration of the present law in an liberal spirit as obtains in Nova Scotia was promised if the Remedial Bill were abandoned. Whether it was for lack of faith in the promises of the Manitoba Ministers, or the determination of the hierarchy to have state-aided Separate Schools at any cost, is not understood; but the Federal Commissioners could not accept the concessions. It now remains to be seen how many more tangible results can be obtained by the minority through the Federal Legislature. There was no conference held to-day, the commissioners and Manitoba Ministers dining and winning together time.

It is proposed to have the final meeting to-morrow morning, when the formal report of the proceedings of the commission will be prepared for submission to the different Governments.
