## BANK ROBBERY.

Four Persons in Jail Charged With the Crime.

**EX-TELLER PONTON ONE OF THEM** 

Pare, the Professional Burglar, Betrays His Confederates and Tells the Story of the Robbery-Ponton Takes His Arrest Very Coolly-Proceedings Before the Magistrate

at Napance. Napanee, July 16 .-- Yesterday at 2.30 a.m. George E. Pare of Manchester, N. H., arrived in charge of Superintendent O'Dowd of that city.

The party, comprising the prisoner and five detectives, drove at once to Magistrate Daly's house and aroused the elderly gentleman from his slumbers. After being furnished with it, Mr. Daly read the indictment:

"George E. Pare, you are accused of breaking into the Dominion Bank at Napanee on the 27th of August, 1897, and extracting therefrom some \$33,000 in

Pare, "Yes, sir." The magistrate then said that he would remand Pare to the jail for eight days,

until a suitable time arrived to hold a preliminary examination. Mrs. Saucier, the sister of Pare, was brought up to-night from Montreal, and is lodged in the jail along with her brother and Mackie, of Belleville.

W. H. PONTON ARRESTED.

The Ex-Teller Taken in Charge on Saturday Evening and Lodged in Napanee Jall.

Napanee, Ont., July 18 .- W. H. Ponton, who was teller in the Dominion Bank here last August at the time of the robbery, was arrested Saturday evening by Chief of Police Adams and Constable Huff, at Massassaga Point, a summer resort on the Bay of Quinte, near Belleville. Ponton was brought here by the midnight G.T.R. express and lodged in

the county jail. If reports are true a declaration sworn to by Pare, the man that was circulating the unsigned bills in Manchester, N.H., waived extradition and was brought here last Friday night, implicates Ponton just as deeply as any of the others, including Mackie of Believille, who is also in jail

After that was done they dispersed, Pare and Holden catching a freight train going east, up the steep grade at this place.

Pare says it was understood and agreed that the money was not to be molested in any way until last June, when they would meet and divide the spoils. Pare says when they did meet in June Ponton admitted taking \$80 from the hidden box. For violating the agreement he was fined \$2,000 and only received \$3,000 as his share, instead of \$5,000.

After Pare had made his confession in Manchester, Detectives Dougherty and Wilkes of the Pinkerton Detective Agency came to Napanee and were accompanied by one or two citizens to the spot described by Pare, when the fence marks were found without any difficulty and close by the empty biscuit box and oil cloth that the money was done up in.

When Ponton was arrested at Massassaga Point he was as cool and apparently unconcerned as though he had never heard of the robbery, and, although brought to Napanee and lodged in jail, still presents the same unconcerned demeanor.

The citizens are greatly excited over the turn affairs have taken, and Ponton's most intimate friends are very uneasy and alarmed over such a mass of circumstances as are claimed to be contained in Pare's confession.

The next move to be made is the extradition of Holden from Boston, Mass., to Napanee. This no doubt will be done early this week and he will be brought

Sympathy for Ponton, Belleville, Ont., July 18 .- William H. Ponton was Saturday night arrested at Massassaga Springs near the city, where he was camping, in connection with the Napanee Bank robbery. Mr. Ponton showed no excitement when arrested. He was taken to Napanee by Chief Adams and Constable Huff, who made the arrest, after a thorough search of his room had been made. Sympathy for the prisoner was shown by a crowd on Front street, by hooting and groans at the officers when they were taking Ponton to a res

Appeal to Toronto. Mr. Porter immediately sent the following message to the Attorney-General's

"Hon. Attorney-General, Toronto: "Am retained to defend Ponton, charged with robbing Dominion Bank, and now in jail here. Jailer refuses to admit counsel to prisoner. Please wire authority to admit counsel.

"E. Gus Porter." After waiting three hours Mr. Porter formally demanded of the sheriff and jailer admission to the jail to interview his client, and was again refused, being told that they were acting under instructions of W. S. Herrington, County Crown Attorney, who was out of town, and who during his absence had handed over the conduct of the proceedings to Messrs, Deroche and Madden, solicitors for the Dominion Bank, and upon application to them by the sheriff they declined to vary

Later the following reply was received by Mr. Porter from the Department; "E. G. Porter, Napanee, Ont.: "Sheriff will be instructed to allow you to see Ponton as early as Wednesday, in

good time at any rate before hearing. "(Signed) J. R. Cartwright," Indignation Prevails. Great indignation prevails here at what is considered an outrage on British justice

Mr. Porter was compelled to return to Belteville without seeing his client, and to wait until the detectives get thoroughly satisfied.

Mackie Is Weakening. Robert Mackie is weakening fast, and confession may be expected at any time from him. It has leaked out that about 50 unsigned Dominion Bank bills were

The prisoners in the jail at present are W. H. Ponton, Ed. Pare and Robert Mackie. None of them wear prison garb. and all have their food sent in to them. All have money, and especially Pare, who has a large amount in the keeping of the jailer. At 7 a.m. the cells are opened, and the prisoners let out. The day hours are spent in reading and walking up and down the corridors, though no communication among them is allowed.

Pare's Confession.

Pare's confession, made at Manchester, N.H., is in the hands of Police Magistrate Daley, who refuses to make it public, except in minor details. He claims to have rich material in his hands. In this confession, it is claimed-thus coinciding with the detectives' theory-that Ponton gave out the combination of the safe, helped to count the swag in his room, and got his share, amounting to \$3,000. Prisoner Ponton is kept supplied with money and an arrest is expected to be made in Belleville that will show where his alleged share of the plunder was placed. > George E. Pare was arrested two days ago in Manchester, N.H., where he had been concealing a large quantity of the stolen bills in an ingenious way. He had bored a hole into a scantling into which he placed bills and plugged the hole. The scantlings were put into a coke box in an outhouse, but the lynx-eyed emissaries of the law hunted out the treasure. Detective Dougherty said: "It was the most

ingenious scheme I ever saw." This man Pare was brought over to Kingston yesterday afternoon, where he was met by Chief Adams and Detective Dougherty and brought up to Napanee on the 2.30 a.m. train. The party drove at once to Magistrate Daley's house, where, after a preliminary examination the prisoner was remanded for eight days and sent to the jail to be under the same roof as Robert Mackie. Pare is a low-set Frenchman, dark, keen-eyed, moustached. "A mighty clever mechanic," said Magistrate Daley, before whom a year ago Pare appeared on a charge of vagrancy.

No one is allowed to see Robert Mackie, son of the proprietor of the Dominion House at Belleville, and a strange circumstance is that even Mackie's lawyer is refused permission to see him, so secluded do the detectives deem it necessary to keep their man. The charge against Mackie is burglary and larceny, no details being given.

It was gleaned from many sources that Mackie has been lately putting away lots of money in the bank, even while losing heavily at the races at Fort Erie. He had just returned from the races, when he was arrested in Belleville, having been in Napanee the day before. - An important discovery was that three coins of a collection that Bank Manager E. H. Baines had specially marked were found upon him, besides about \$40 or \$50. These odd all on the scent. The fact of their having been found is told in a stage whisper with many a "Don't say I told you." Mackie is said to have been seen with Holden frequently last summer. That is where he comes into the story.

But the surprise of the whole affair remains to be told for the first time. It is thought that Pare squealed on the rest of the gang. Even Holden has intimated his fear of that, for immediately on Detective Dougherty's return from Manchester, N.H., on Thursday, he, Lawyer Madden and the section boss drove out east along the G.T.R. tracks to the first half-mile post. Straight north of this post, which is on the north side, there was a board in the fence labelled, "G. T. R.," having cut into it underneath an initial letter. This board has been cut off, and is in the hands of the detectives.

Right under the fence was found a hole about a foot in diameter, and a foot and a half deep, from which was taken a box, in which was found a money bag, the very one taken from the Dominion richest find of the whole discovery. Those who think this box contained burglars' tools are mistaken, for it held evidence which the detectives consider to be the greatest surprise they have met with, and are confident that its discovery will lead to other arrests. It is thought that this box contained the share of the plunder that was to be given to those members of

the gang that lived in the vicinity. So far it is estimated that \$9,000 of the stolen bills have been recovered. Lawyer Davidson of Montreal, E. H. Baines, R. D. Gamble and the American Consul from Belleville are in town, preparing the extradition papers to be served immediately upon Holden in Boston.
