CORNERED SOME WITNESSES.

An Acquaintance of Esterhasy on His Character-Dreyfus Continues Calm and Again Makes a Good Impression-Labori Promises That He Will Give Gen. Mercier a

Warm Time.

Rennes, Aug. 22.-Maitre Labori, leading counsel for the defence, who was murderously assaulted Aug. 14, was present in court this morning when the second day court-martial of Captain Alfred Dreyfus of the artillery, charged with treason, began. The proceedings opened at 6.30 a.m. The arrival of M. Labori at the Lycee was the signal for scenes of extraordinary enthusiasm. At 6.15 a.m., three carriages, preceded by a number of bicycles, drove up. The first carriage contained M. Labori and his wife and physicians. The others contained friends of the lawyer and some police inspectors. The crowd about the Lycee building rushed up to M. Labori's licarriage, and a number of people eagerly thrust their hands through the windows to greet the distinguished lawyer.

When M. Labori descended he was surrounded by friends and a hundred hands pressed his, while he was assailed with M. Labori's statements. Labori and a physician, entered the court room the audience greeted him by standing to relate how when he left Lieut.-Col. Berstreets. Tears sprang to the eyes of the wounded man, who was evidently deeply affected by the warm welcome accorded him. Among those who greeted M. Labori were Generals Billot and Mercier, who courteously inquired as to his condition. Dreyfus entered the court room soon afterwards and after saluting the judges in the usual manner, he turned to M. Labori with outstretched hands and a smile of keen pleasure lighted up his pale and usually impassive features. The

The U S. Spanish War Not a World

Beaking Affair Leslie's Weekly, New York: It would be just as well, if not better, if we were a little more modest in our talk about the victories won over the Spaniards in Cuba and elsewhere last year. Without any disparagement of the real valor or efficiency of our men or their leaders on land or sea, justice demands it to be said that most of the battles were won over a foe weakened and crippled by a criminal lack of care and equipment by the Spanish home government.

The testimony of General Toral and Admiral Cervera before the recent court martial at Madrid brought out these facts in a strong light. According to General Toral, the Spanish soldiers in Santiago, at the time of the surrender, were on the verge of utter collapse from hunger, sickness ance wounds, and the wonder is that they were able to fight as well and as long

as they did. From Admiral Cervera's correspondence laid before the court, it is learned that the heroic old fighter had warned his government, long before the final disaster came, that Spain had few ships fit for use, and they were "armed pretty much anyhow, and had no provisions." Nothing could be expected from the expedition to Cuba, he declared, but the destruction of the fleet.
