DEATH OF LIEUT. COL. DAWSON.

Deceased had apparently enjoyed the best of health. He had taken a pleasant walk with a number of friends yesterday afternoon, and had never been in more jovial spirits. Major Bruce and Mr. Torrance had returned with him to his home, 236 College-street, to dine. Their host was about snowing them to the table when he fell to the floor. Dr. Spragge was immediately summoned, but in a few minutes the ex-commander of the Royal Grenadiers was dead. A widow and four children mourn a kindly husband and father's loss. Bank at Uxbridge. Of late years deceased had been conducting a large wine business under the firm name of G. D. Dawson & Co. at 16 King-street west. The news of his sudden death was a great shock to his many friends, and his military companions were about to make preparations The arrangements for the funeral, ing carried out by Mr. Millard. Lieut.-Col. Dawson retired from the command of the Royal Grenadiers, re-

taining rank, on Dec. 1, 1893, when he was succeeded by the present com-mander, Lieut.-Col. Mason. He was born on Jan. 7, 1839, in the County of Carlow, Ireland. He was the second son of Rev. George B. Dawson, who was for more than 30 years rector of the parish of Agade in that county. His mother was a sister of Lieut. Gen. Sir Dudley Hill, K.C.B. From this side of the house he derived both martial instincts and a name. Gen. Hill died in command of a division in India in 1852. Young Dawson received his education by private tuition at Kilkenny College, and entered the army when 16 years of age, on March 16, 1855. He was ordered to the Crimea in October of the same year, but when the ship arrived at Malta, news of the armistice was received, and no more troops were sent on. He remained at Malta for a year, and returned to England in the autumn of 1856. He served in various parts of England and Ireland from 1856 to 1861. He took a first-class certificate at the School of Musketry, Hythe, in 1859, and acted as assistant instructor of musketry to a depot battalion at Cork and also at Athlone, Ireland, for two years. He came to Canada with the 47th Regiment in 1861, and he held the appointment of out-post officer for four years at Kingston, Hamilton and To-

ront). He also acted as brigade major to the field force under Col. Lowry during the Fenian raid at Fort Erie in 1866. In 1867 he sold out at Halifax. He married on Jan. 7, 1869, Elizabeth, eldest daughter of the late R. P. Crooks, barrister of this city, and niece of Hon. Adam Crooks, late Minister of Education for Ontario. He went into business as a wine merchant n 1870 at Toronto, in partnership with Mr. E. H. Foster, but the latter retired from the partnership in 1875. He founded in 1871 the Bodega Wine Company of Canada, with branches at Montreal and Ottawa. On the reorganization of the old 10th Royals, under the name of the Royal Grenadiers, in 1880, under Lieut.-Col. Grasett, he became senior major of the regiment and assisted largely in its development. While bearing this rank, Major Dawson served : 11
